Re: Extension Request for Submittal of Cleaner Air Oregon Emission Inventory – Hollingsworth & Vose Fiber Company

Anita Ragan,

On April 11, 2022, Hollingsworth & Vose Fiber Company (H&V) submitted a Cleaner Air Oregon (CAO) Emission Inventory (Inventory). On June 8, 2022, DEQ sent H&V a letter requiring additional information, corrections, and updates to the Inventory to be provided by July 8, 2022. On June 21, 2022, DEQ received a request for a partial extension to this deadline. The extension request pertains specifically to information required to verify the calculation of emissions from the TCE removal system (TEUs REMSYS, LEAKS_SVE, LEAKS_SS, LEAKS_CV1, and LEAKS_CV2), and requests that these requirements be postponed until 60 days from the issuance of the pending Consent Judgement related to the TCE removal system for cleanup site, ECSI #40.

Based on the definition of “source” in [OAR 340-200-0020\(166\)](#), the TCE removal system is not regulated as part of the H&V stationary source (Source #02-2173) which was called in to the CAO program on January 10, 2022. Health risk from the TCE removal system will be overseen by DEQ’s Cleanup Program under the pending Consent Judgement, consistent with ORS 465.315(3). DEQ is therefore amending its June 8 request to remove Requirement 9, Requirement 10b, and the portion of Requirement 10a which refers to TEUs REMSYS, LEAKS_SVE, LEAKS_SS, LEAKS_CV1, and LEAKS_CV2.

In lieu of granting the extension requested, DEQ requires that emissions from the TCE removal system (TEUs REMSYS, LEAKS_SVE, LEAKS_SS, LEAKS_CV1, and LEAKS_CV2) be removed from the Inventory and supporting documentation, prior to the current deadline of **July 8, 2022**.
