

Manufacturer Registration Information

This fact sheet is provided to assist manufacturers with the annual registration process as part of the Oregon E-Cycles Program. Manufacturers must register annually with the Department of Environmental Quality's Materials Management Program, as part of part of the requirements found in statute at ORS 459A.305 to 459A.365 and administrative rule, found at OAR 340-098-0010 to 340-098-0270. Manufacturers are responsible for understanding and fulfilling all requirements under the law.

What's new in 2026

In 2023, the Oregon Legislature passed House Bill 3220, updating the state's electronics recycling law. The revised law:

- Expands the list of covered devices eligible for collection and recycling
- Modernizes manufacturer registration and reporting requirements
- Discontinues the state contractor program and instead requires manufacturers to designate an electronics producer responsibility organization
- Ensures stability among the statewide collection site network

2026 registration period

Registration for the 2026 program year runs from **Oct. 15 through Dec. 31, 2025.** Registration is required annually for all manufacturers of covered electronic devices.

Who must register

Your company must register for 2026 if:

- You sell or offer for sale covered electronic devices in or into Oregon in 2026, or
- Your brands were sold in Oregon in 2025 and are not being registered for 2026 by another manufacturer.



What devices are covered in 2026

The updated law expands the definition of covered devices. For 2026, these include:

- Cable receiver
- Computer (desktop, laptop, tablet, e-Reader, all-in-one)
- Computer monitor
- Portable digital music player
- Printer (excludes 3D printers)
- Router
- Satellite receiver
- Scanner
- Small-scale server

- Television
- VCR player
- Video game console
- Digital converter box
- DVD player
- DVR device
- Fax machine
- Modem
- Peripherals (such as keyboards, mice, headphones, or controllers)

How to register

All manufacturers must register online at the <u>registration portal</u>. This portal is managed by the Electronics Recycling Coordination Clearinghouse.

Steps to register:

- 1. Create or log in to your account
- 2. Enter updated company and contact information
- 3. List all brands (current and past) associated with covered devices
- 4. Confirm your intended 2026 Producer Responsibility Organization
- 5. Certify that the information provided is accurate and that your company understands its responsibilities under the updated law

Compliance requirements

To legally sell covered devices in Oregon in 2026, manufacturers must:

- Register with DEQ by Dec. 31, 2025
- Submit required market data to DEQ
- Designate a PRO with an approved plan by DEQ
- Maintain current company and brand information

Manufacturers must comply with all requirements under Oregon E-Cycles for their covered devices to be sold legally in or into Oregon. Failure to comply may result in civil penalties under ORS 459.995.
