




What is the Climate Protection Program?

- Transportation






Climate Protection Program timeline





Community climate investments



- Reduce anthropogenic greenhouse gas emissions
- Projects in residential, industrial, commercial, and transportation sectors
- 15% of funds must benefit tribes and tribal communities in Oregon



Community Climate Investment priorities

- Reducing greenhouse gas emissions on average at least one ton per CCI credit
- Reducing emission of other air contaminants, particularly in or near environmental justice communities
- Promoting public health, environmental, and economic benefits for environmental justice communities
- Accelerating the transition to clean energy particularly in or near environmental justice communities









Eligible projects

Actions that reduce greenhouse gas emissions from:

- Transportation of people or freight
 - le) Diesel fleet replacement with electric
- Residential structures
 - le) Installing heat pumps or weatherizing
- Industrial processes or structures
 - le) Increasing energy efficiency
- Commercial structures
 - le) Installing solar and storage on a business







Prioritizing environmental justice communities

Environmental justice communities means communities of color, communities experiencing lower incomes, communities experiencing health inequities, tribal communities, rural communities, remote communities, coastal communities, communities with limited infrastructure and other communities traditionally underrepresented in public processes and adversely harmed by environmental and health hazards, including seniors, youth and persons with disabilities.



Equity Advisory Committee experience

- Environmental or economic justice
- Climate change impacts and experience
- Air pollution and/or health and community impacts
- Transportation decarbonization
- Residential and commercial building decarbonization
- Industrial decarbonization
- Clean, renewable energy, or energy efficiency

Charter - agreements

Members agree to the following:

Operational agreements: (procedures or structures the committee agrees to use)

- Prepare for and set aside time for the meetings to be as present as possible.
- Try and arrive 10 minutes early so we can start on time and address any technical issues.
- Communicate with DEQ staff if you are unable to make the meeting.
- Connect regularly with communities, membership, partners, etc. to inform them and gather input on community climate investments process, potential projects, and opportunities for engagement.
- Avoid representing to the public or media the views of any other committee members or on behalf of the committee.


Relational agreements: (how the committee agrees to engage with one another)

- Be curious, open, and respectful.
- Take space/make space if you are usually quiet challenge yourself to take more space, and if you usually talk a lot be mindful to make space for others to speak.
- Avoid jargon, acronyms, and industry language use inclusive language that is accessible for people with varying inside knowledge.
- Speak from your own experience use I statements rather than generalizations.
