1. Executive Summary

The Drug Takeback Solutions Foundation's ("Foundation") Drug Take-Back Program Plan ("Approved Plan") was approved by the Oregon Department of Environmental Quality ("Department") on June 4, 2021, pursuant to ORS 459A.200 to 459A.266 and related rules ("Drug Take-Back Law"). The Approved Plan requires that the Foundation submit an Annual Report to the Department detailing the development, implementation, and operation of the Drug Take-Back Program ("Program") for the preceding year. This Annual Report covers collection and outreach activities from July 1, 2023 to June 30, 2024 ("Reporting Period"), in compliance with ORS 459A.230.

The Foundation has provided drug take-back services for Oregon residents that have accumulated in the collection of over 70,000 pounds of unused and unwanted medication. During its time as a program operator, The Foundation has utilized digital and print outreach tactics to garner more than 36 million impressions.

During the Reporting Period, the Foundation operated 182 Kiosks at Drop-off Sites across the state of Oregon. The network of Drop-off Sites expanded by 13 new locations. In line with an approved Request for Additional Services, the Foundation also conducted 27 collection events in 75 population centers where Drop-off Sites could not be established. Additionally, the Foundation operated Mail-back Distribution Sites at 479 locations across the state. Direct mail services were provided to Lonerock, Antelope, and Shaniko where it was not feasible to establish Mail-back Distribution Sites within the population centers.

The Foundation utilizes various methods such as phone calls, emails, site visits, maintenance requests, or proof of liner returns to verify sites are active. To ensure the accuracy of the reporting of Drop-Off Sites and Mail-back Distribution Sites is maintained, the operational personnel utilized internally created reports, Change Log, and Weekly Updates to identify changes in account details.

To promote awareness of these collection methods, the Foundation employed targeted outreach efforts directed at population centers and Historically Underserved Communities throughout the state. These campaigns included direct mail, print ads, influencer marketing, programmatic/social media campaigns, as well as radio and television advertisements. Promotional materials were made available on the Program Website and distributed to Authorized Collectors upon request.

Overall, the Foundation's program achieved a 49.96% increase in weight of collected drugs compared to the previous year. The Foundation continues to explore opportunities to increase the number of Drop-off Sites statewide, enhance public awareness, and boost collection rates.

The Foundation's Program had a total of 182 Drop-off Sites participating during the program year. The three Drop-off Sites listed below stopped participating during the Reporting Period.

The Foundation added 13 Authorized Collectors to the program during the Reporting Period. The Foundation worked with each of these 13 new Authorized Collectors to assess the feasibility of providing Auto-injector Mail-back Packages onsite. Where space was available to store and distribute these items, at least 5 Auto-injector Mail-back Packages were provided.

The Foundation has an extensive mail-back services network that provides prepaid, pre-addressed Mailers to all Covered Entities at no cost. Three types of Mailers, including Standard Mail-back Envelopes, Inhaler Mail-back Envelopes, and Auto-injector Mail-back Packages, are available at the 479 Mail-back Distribution

¹Of the total weight collected, 65.64% (19,965.08 pounds) originated from population centers under 100,000 people, totaling 19,965.08 pounds. This includes 48.11% (14,632.69 pounds) from areas with populations under 50,000, 34.92% (10,621.37 pounds) from those under 25,000, and 15.88% (4,828.24 pounds) from communities with fewer than 10,000 residents. This collection distribution highlights the program's significant reach into underserved communities, reflecting a strong effort to make drug take-back services broadly accessible across a range of population sizes, even in areas where kiosk placement has proven more challenging.

The Foundation added 13 Authorized Collectors to the program during the Reporting Period. As outlined in the Foundation's Program Plan (approved June 2021), the Foundation worked with each of these 13 new Authorized Collectors to assess the feasibility of providing Auto-Injector Mail-back Packages onsite. 10 of the new Authorized Collectors indicated that they had the space to store Auto-Injector Mail-back Packages on-site, and were provided at least 5 Auto-Injector Mail-back Packages. The remaining 3 new Authorized Collectors enrolled at the end of the program year, which did not allow enough time to send Auto-Injector Mail-back Packages before the start of Program Year 4. Those 3 new Authorized Collectors received at least 5 Auto-Injector Mail-back Packages early in Program Year 4. Additionally, the Foundation has provided at least 5 Auto-Injector Mail-back Packages to all existing Authorized Collectors.

Covered Entities may request up to 3 Standard Mail-back Envelopes, Inhaler Mail-back Envelopes, or Auto-injector Mail-back Packages at a time via the Program Website or the Program Toll-free Phone Number.

The Foundation has also established 479 Mail-back Distribution Sites. Covered Entities may pick up any type of Mailer from a Mail-back Distribution Site and return it to the Foundation at their earliest convenience. This network, combined with the Foundation's network of Drop-Off Sites ensures that 99% of Covered Entities are within 15-mile radius of a Drop-Off Site or Mail-Back Distribution Site. A list of the locations and amounts of Covered Drugs collected from each Mail-Back Distribution Site is provided in Appendix C.

Hospice Mail-Back Efforts

The Foundation continued to operate mail-back efforts in Hospice locations across the state of Oregon. A total of 172 envelopes were returned for destruction, totaling 61.92 pounds from hospice locations during the program year. Additionally, 1,000 new



mail-back envelopes were distributed to Hospice locations this program year.

Partnership with Costco

Foundation's partnership with Costco has yielded 978 envelopes returned and 364.36 pounds of medication returned during this program year.

The Foundation has also established 479 Mail-back Distribution Sites. Covered Entities may pick up any type of Mailer from a Mail-back Distribution Site and return it to the Foundation at their earliest convenience. This network, combined with the Foundation's network of Drop-Off Sites ensures that 99% of Covered Entities are within 15-mile radius of a Drop-Off Site or Mail-Back Distribution Site. A list of the locations and amounts of Covered Drugs collected from each Mail-Back Distribution Site is provided in Appendix C.

The Foundation made over 550 emails and phone calls to city & county level Law Enforcement Agency's (LEAs), Solid Waste Facilities, and local & county level community leaders in order to hold collection events throughout the state. Through all of those efforts, the Foundation ran 27 collection events throughout the program year. These efforts netted a total of 836.10 pounds of weight collected across all of the events.

The Foundation provided the following additional services where Drop-Off sites could not be established:

 For Program Year 3, the Foundation used its existing extensive network of Mail-back Distribution Sites to provide service to cities and counties without Drop-Off Sites. The Foundation operates 479 Mail-back Distribution Sites in 153



population centers² where the Foundation has not established a Drop-Off Site. As noted above, when combined with the Foundation's Drop-Off Sites, 99% of Covered Entities live within a 15-mile radius of either a Mail-Back Distribution Site or a Drop-Off Site, and 90% of Covered Entities live within a 20-minute drive of one of these locations. During Program Year 3, the Foundation collected 126% more Covered Drugs from its Mail-back network, indicating that services are growing and more Covered Entities are taking advantage of the convenience of Mail-back services. A list of all Mail-back Distribution Sites used during the program year, along with the weight of drugs collected at each location, is included in Appendix C. The Foundation was able to collect a total of 729.11 pounds through this network.

• The Foundation also proposed to host 67 Collection Events unless "it is not possible to establish a collection event in a desired location due to lack of cooperation from host sites and law enforcement agencies." The Foundation conducted significant outreach to cities and counties without drop-off sites to offer to host Collection Events. To host a Collection Event, the Foundation must coordinate and secure participation from local law enforcement in accordance with DEA regulations, as well as collaborate with local solid waste management and obtain concurrence from the appropriate local governments in the affected population center. If these entities do not respond or are unwilling to participate, the Foundation cannot hold an event in that population center.

To achieve this coordination, the Foundation sent over 550 emails and made phone calls to city and county-level law enforcement agencies (LEAs), Solid Waste Facilities, and local and county-level community leaders in population centers without drop-off sites. All 153 population centers without drop-off sites were contacted at least once through this outreach. Due to these extensive outreach efforts, the Foundation conducted 27 events throughout the program year, covering 75 population centers and resulting in 836.10 pounds of drugs collected across all events.

 During Program Year 3, the Foundation also received approval to provide Direct Mail Services to three population centers requiring additional services: Antelope, Lonerock, and Shaniko. Based on the populations in each of these locations, the Foundation distributed 66 Standard Mail-Back Envelopes along with information about how to return them. None of these envelopes were returned during the program year.

²During Program Year 3, the Foundation received approval to not provide additional services for five population centers because the population was zero (Greenhorn) or the population centers are in such proximity to drop-off sites that no additional services need to be provided (Dunes City, Johnson City, King City, and Maywood Park). Covered Entities in these population centers could still request envelopes or packages through the approved Program Website or by calling the Program Toll-free Phone Number at 1-800-350-0396, option 5.



Through the combination of services offered in Program Year 3, as detailed above, and the promotional materials provided below, the Foundation delivered additional services to population centers where a Drop-Off Site was not established.

The Foundation's Service Provider used the transporters and disposal facilities listed above, which have been previously notified to DEQ. These transporters and disposal facilities were selected due to resource availability and a shifting landscape within the waste industry, which included facility closures and waste backups at hazardous waste facilities. Per ORS 459A.224, covered drugs were disposed of at (1) a hazardous waste disposal facility that meets the requirements of 40 CFR parts 264 and 265, as in effect on September 29, 2019; or (2) at a municipal solid waste incinerator that is permitted to accept pharmaceutical waste.

5. Safety or Security Concerns

The Foundation encountered the following safety and security problems during the collection, transportation, or disposal of drugs during this Reporting Period. In accordance with ORS 459A.230(1)(j), the Foundation provided timely notification to DEQ regarding each event:

- On October 31, 2023, two separate kiosks—Sav-On Pharmacy #3529 (1675 W 18th Ave, Eugene, OR) and Safeway Pharmacy #4513 (350 E 40th Ave, Eugene, OR)—were breached by individuals who forcibly accessed the kiosks and removed the inner liners containing medications. The Foundation was notified of both incidents on November 2, 2023, and submitted official notification to DEQ on November 10, 2023.
- A third incident occurred on November 18, 2023, at Sav-On Pharmacy #0572 (311
 Coburg Road, Eugene, OR), when two individuals accessed a drug receptacle and
 stole its contents. Notification of the event was received by the Foundation on
 November 19, 2023, and a formal report was submitted to DEQ on November 28, 2023.

For each incident, the Foundation coordinated with Albertsons pharmacy staff and corporate teams to notify local law enforcement and DEA Field Offices. New kiosks were ordered for each affected site. The Foundation also engaged with its kiosk manufacturer to assess potential security vulnerabilities. No changes in kiosk design were deemed necessary at this time, but the Foundation continues to collaborate with its partners to monitor risks and deter criminal activity.

6. Public Awareness and Education

Website, Written Materials Provided, Signage, and Advertising Pursuant to ORS 459A.227(1):

Pursuant to ORS 459A.227, the Foundation executed a comprehensive and measurable public awareness and education strategy to drive awareness of the Program and maximize participation by all Oregonians. The goal of the Foundation's public awareness and education efforts was to ensure that Covered Entities and Authorized Collectors across Oregon were well-informed about where and how to return Covered Drugs.

To accomplish this, the Foundation deployed a combination of outreach initiatives, including printed materials and media communication. Pursuant to ORS 459A.227(1)(a)-(d), each initiative aimed to instruct Covered Entities by delivering at least one, if not all, of the following key messages:

- Promote the safe and secure storage of Covered Drugs by Covered Entities.
- Raise awareness of the inherent risks of improperly storing or disposing of opioids, opiates, and other Covered Drugs.
- Discourage the disposal of Covered Drugs in the garbage or sewer system.
- Promote the disposal of Covered Drugs through the use of the Drug Take-back Program, including publicizing information on Drop-off Sites, hours of operation, Mail-back Services, collection processes, and any Collection Events.

The Foundation continued its service of a toll-free telephone number and website for Covered Entities to contact the Foundation regarding the Program. These services were accessible to all community members across Oregon. Additionally, the Foundation used Kiosk signage to build public awareness. The Foundation also empowered and educated Kiosk staff on the importance of proper drug disposal, ensuring that public awareness was supported wherever a drop-off site was available. A summary of the initiatives deployed as part of the Foundation's public awareness and education strategy is provided below.

Education Materials

In accordance with ORS 459A.227(1)(a)-(d), educational materials are available to Covered Entities on the Program Website and through distribution to Authorized Collectors upon request. These Educational Materials promote the safe and secure storage of Covered Drugs while educating Covered Entities on best practices for the disposal of Covered Drugs through the use of the Drug Take-Back Program.

Educational materials have been translated into six languages (English, Spanish, Russian, Chinese, Vietnamese, and Somali) to ensure that all Covered Entities have easy and convenient access to the information.

Although the Foundation did not receive any requests for printed educational materials during the Reporting Period, all new Drop-off Sites added during the Reporting Period received promotional materials in their welcome packet upon enrollment as an Authorized Collector. This welcome packet also included information on how to request additional



promotional materials, either by 1) requesting materials on the website to be downloaded or 2) contacting the Foundation to request that promotional materials be printed and shipped to the drop-off site at no cost. The retail drug outlets, on-site pharmacies, health care clinics with on-site pharmacies, and law enforcement agencies that received these education materials in the Reporting Period are listed in the table below.

Kiosk Signage

Prior to the Reporting Period, Kiosk Signage was created and implemented to educate and assist Covered Entities in the proper storage and disposal of Covered Drugs. In accordance with ORS 459A.227(1)(g), and in partnership with the other Program Operator, a common mark logo was created to provide a common symbol for Covered Entities to identify Collection Methods and educational materials associated with the Program.

Direct Mail

In accordance with ORS 459A.227(1)(a)-(d), the Foundation utilized direct mail (5x7 postcard) to promote safe drug disposal and raise awareness of the joint neutrally-branded website,



<u>medtakebackoregon.org</u>. A total of 91,002 direct mailings, translated into both Spanish and English, were sent out. These postcards highlighted important statistics, the joint neutrally branded website, the toll-free phone number, a visual of the Kiosk, and instructions on how to operate it. For examples of the direct mail materials, refer to Appendix D.

During Program Year 3, the Foundation collaborated with its direct mail vendor to increase the number of mailers sent per activation. Although this process required extended coordination, the groundwork laid in Program Year 3 led to the successful implementation of the increase at the start of Program Year 4.

Direct Mail postcards were also used to drive awareness of take-back events in the respective communities. A total of 43,582 postcards were sent to covered entities in population centers where events were held, as well as to surrounding population centers requiring convenience coverage.

Print Advertisements

In accordance with ORS 459A.227(1)(f), the Foundation collaborated with twelve regional newspapers across Oregon to educate and inform Covered Entities about the joint neutrally-branded website and toll-free phone number, as well as the locations of Drop-off Sites, Mail-back Distribution Sites, and Collection Events. The newspaper advertisement was featured in both the print and online editions of these twelve newspapers, where available. These newspapers collectively have a weekly readership of 116,411 Oregon residents. An example of the newspaper advertisement can be found in Appendix D. During this program



year, we initiated communication with *The Oregonian* and plan to expand the print advertisement reach to include their publication during Program Year 4.

Programmatic Media

Programmatic Media provides targeted display ads on browser sites across internet-capable devices (smartphones, computers, tablets, etc.). The Foundation ran ads on a prequalified list of over 200,000 domains, including a variety of retail websites, Google, and Facebook. Impression metrics are reported directly by the individual websites where the ads were placed, and results are tracked on a per-campaign basis. The Foundation can increase the number of programmatic campaigns utilized if reach and frequency standards are not met. For examples of Programmatic Media, refer to Appendix D.

Influencer Marketing

Influencer Marketing is a content creation strategy used to drive awareness and education among a targeted audience through blogs and social media outlets. Influencers create original, authentic content centered around their everyday lives and interests while incorporating the story of drug take-back into their messaging. This content is then converted into paid ad units across various social platforms and targeted to community members across Oregon. Paid advertisements for influencer content were run on platforms such as Google, Facebook, and Instagram, aimed at reaching a specific impression goal.

The Foundation ran quarterly social media influencer campaigns and has now recruited Spanish-speaking influencers to create content on safe drug disposal in their native languages. This approach allows specific demographics to engage with content tailored to their language and cultural needs. The Foundation can increase the number of influencer campaigns and paid advertisements if the impression and frequency standards are not met. Radio and Television

The Foundation introduced radio and television ads during this program year. A total of 1,011 30-second radio spots were aired across three radio stations, and a 30-second television ad ran for one month. The advertisements focused on educating the public about safe drug disposal and directed listeners and viewers to find more information at medtakebackoregon.org. The ads emphasized that safe drug disposal options are free and convenient for all residents of Oregon.

The Foundation has actively engaged with radio and TV stations across Oregon to discuss strategic placements for public service announcements (PSAs), aiming to maximize the reach and impact of its educational messaging. In addition to coordinating placements, the Foundation has invested considerable effort in developing the ad units themselves, ensuring they are tailored to effectively inform residents about safe drug disposal options. These initiatives reflect the Foundation's commitment to expanding its media presence and reinforcing the accessibility of convenient, no-cost disposal options for all Oregonians.

Website

Pursuant to ORS 459A.227(1)(e)-(f), the Foundation established an individually branded website during the Reporting Period. The URL for the Foundation's website is www.SafeMedicineDrop.com. The website can be translated into six languages, including English, Spanish, Russian, Chinese, Vietnamese, and Somali. It features a map and list of Drop-off Sites, Mail-back Distribution Sites, and Collection Event locations, along with dates and times for all Covered Entities in Oregon. Covered Entities are able to request Mailers, including Standard Mail-back Envelopes, Inhaler Mail-back Envelopes, and/or Auto-Injector Mail-back Packages, to be sent directly to their residence with instructions on how to return the Mailers. The website also provides additional information on the Foundation's Program, including a Frequently Asked Questions (FAQ) section.

Pursuant to ORS 459A.227(3), the Foundation, along with the other approved Program Operator, established a joint neutrally-branded website and toll-free phone number during the Reporting Period. The URL for the neutral website is www.medtakebackoregon.org, and the toll-free phone number is (844) 482-5322. Covered Entities can visit the neutral website to view a map and listing of all Collection Methods, including Drop-off Sites, Mail-back Distribution Sites, as well as Collection Event locations, dates, and times from all Program Operators in Oregon. The neutral site, toll-free number, and outreach materials are available in six languages: English, Spanish, Russian, Chinese, Vietnamese, and Somali. The website also offers additional translation options and provides direct links to both Program Operators' individually branded websites, where Covered Entities can order Mailers and access further information.

Biennial Survey

Pursuant to ORS 459A.227(1)(f) and ORS 459A.227(2), the Foundation conducted a survey to Covered Entities, Pharmacists, and Medical Professionals. The survey was designed to



measure public awareness, the convenience of different Collection Methods, and to assess the knowledge and attitudes towards the risk of improperly storing/discarding/abandoning Covered Drugs. The Survey was created in both an online and telephone survey format and was available in English, Spanish, Chinese Mandarin, Russian, Tagalog, Vietnamese, and Somali. A total of 1,280 participated in the survey. Below is a breakdown of these individuals:

- Total Survey Participants 1280
- English Speaking Participants 1200
- Spanish Speaking Participants 31
- Chinese Speaking Participants Residents 24
- Russian Speaking Participants Residents 12
- Vietnamese Speaking Participants Residents 13

Following are highlights of the Biennial Survey results³:

- Pursuant to ORS 459A.227(2)(b)(A), the Survey found 45.73% of respondents were aware of the Oregon Drug Take-back Program.
- Pursuant to ORS 459A.227(2)(b)(B), the Survey found that 77.17% of respondents responded positively to the convenience of the Program's Collection Methods.
- 90.10% of respondents responded positively to the Ease of Use of the Program's Collection Methods.
- Pursuant to ORS 459A.227(2)(b)(C), when asked about their sentiment toward drug abuse in the household, contaminated drinking water, and fish and wildlife health from flushing medication:
 - 90.92% and 90.37% respectively had concerned responses toward improper medication disposal having an effect on contaminated drinking water and fish and wildlife health.
 - 55.64% of respondents had concerns regarding drug abuse in the household.
 44.36% of respondents answered that they had no concern around this matter.

Printed Promotional Materials Provided Pursuant to ORS 459A.227(4):

In accordance with ORS 459A.227(4), the Foundation distributed promotional written materials to Retail Drug Outlets, hospitals with an on-site pharmacy, and health care clinics with an on-site pharmacy so that they could, upon request, provide these materials to Covered Entities at the time that a Covered Drug was delivered. These materials were also made available on the Program's website.

These materials:

- Provided instruction on how to safely store Covered Drugs at home.
- Informed about the risks of disposing of Covered Drugs in inappropriate waste streams (e.g., solid waste collection, sewer, or septic systems).
- Outlined how to participate in the Drug Take-back Program for safe disposal of Covered Drugs.

The Foundation has a plan for covering the costs of the six month closure period in the unlikely event of a dissolution of the Program. The plan is to pro-rate our agreements with manufacturers to include the run-out period of six months in order to cover costs and provide the manufacturers with enough time to secure the services of another stewardship organization. Additionally, the Foundation has notification provisions with each of our vendors if such an event should occur to secure their services until the dissolution is finalized.

Collection

The Foundation made significant progress towards meeting its Program Year 3 Collection Goals, achieving a 49.96% increase in the overall weight of collected drugs compared to Program Year 2 (from 20,327.29 lbs in Program Year 2 to 30,481.81 lbs in Program Year 3). The Foundation's long-term goal is to increase collection weight by 10% each year. While the overall collection weights have not yet reached the original goal of 20 pounds per month per Drop-off Site, the trends are positive, with collection weight continuing to increase. Notably, the Foundation achieved an increase of more than 10% in collection weight, demonstrating that the longer a Kiosk exists and the more awareness is built in the community around it, the higher the collection rates will be over time.

The weight collected from Drop-off Sites increased by 46.12% compared to the previous program year (from 19,743.56 lbs in Program Year 2 to 28,848.62 lbs in Program Year 3), while the weight collected through mail-back services increased by 36.61% across all mail-back distribution methods (from 583.48 lbs in Program Year 2 to 797.09 lbs in Program Year 3).

Public Awareness

The Foundation's long-term public awareness goals include reaching 75% of Covered Entities across Oregon, improving Kiosk usage, and increasing awareness among Historically Underserved Communities. The Foundation made significant progress toward this goal, measured by 18.9 million impressions through views, listeners, readership, and home



addresses across various outreach tactics implemented throughout the Reporting Period (see Section 6). The Foundation has increased its public awareness goal metrics by 20.6% year over year.

- -Sustain a 75% reach to Covered Entities in Oregon annually measured by survey results.
 - The Foundation survey found that 45.73% of respondents were aware of the Oregon Drug Take-Back Program.
- -Measure the goal for Kiosk use, set a baseline, and make plans for improvement.
 - Awareness and usage of Kiosks across Oregon increased significantly, with a 46.12% year-over-year increase in Kiosk weight.
- -Increase Program awareness for Historically Underserved Communities until 75% of Covered Entities within these communities are reached.
 - In line with the Foundation's Project Plan for Historically Underserved Communities (updated Mar. 31, 2022), continued efforts were made in Program Year 3 to target historically underserved communities across Oregon. As described above, the Foundation conducted public awareness campaigns that created multiple touchpoints (newspaper, direct mail, online, TV, radio, etc.) and educational opportunities for individuals in Historically Underserved Communities and Oregonians at large.
 - Over 65% of the Foundation's total weight collected was from population centers with less than 100,000 people.
 - Additionally, the Foundation expanded its public outreach efforts by adding television and radio campaigns. These tactics introduced two new platforms to further diversify the outreach plan, providing Covered Entities with more opportunities to engage with and access information about the program, as well as medtakebackoregon.org.
