

Introduction to Recycling Acceptance Lists

Background Paper for August 18, 2022, Oregon Recycling Council Meeting

This document describes a project to identify lists of materials for recycling under Oregon's Plastic Pollution and Recycling Modernization Act, and introduces initial recommendations for placement of some materials on recycling collection lists.

Background

Oregon law requires local governments to provide an "opportunity to recycle". The exact requirements (ORS 459A.005 and .007) depend on the size and location of the local government. The standard approach includes a depot at the disposal site or a more convenient location, at-least monthly collection of recyclables from all service customers, and additional services (including more frequent service) drawn from a menu of elements. Currently, each local government chooses which materials to collect. That will change in 2025 under the Plastic Pollution and Recycling Modernization Act. Oregon's Environmental Quality Commission will define what constitutes a "recyclable material" after considering criteria such as end markets, economics and environmental impacts. The Commission will designate some materials as "opportunity to recycle" obligations for local governments and others as separate recycling obligations for Producer Responsibility Organizations to collect via depots or mobile collection events.

Current Evaluation and Rulemaking

DEQ has initiated a rulemaking that includes, among other topics, identifying:

- Materials that local governments must collect for recycling under their Opportunity to Recycle obligations.
 - For those materials, designate which are appropriate for collection at recycling depots, on-route collection, or both; and
 - Which materials must be collected separately (e.g., motor oil) and which may be collected commingled (the "Uniform Statewide Collection List").
- Materials that PROs must provide collection and recycling for.
 - For those materials, identify convenience standards, collection targets, and performance standards that Producer Responsibility Organizations must meet.

DEQ may also designate covered products as a "specifically identified material." Such a designation creates additional obligations by the PROs.

Rules concepts related to these lists will be brought to a Rulemaking Advisory Committee for discussion later this year. To develop the concepts, DEQ is currently evaluating materials and possible future scenarios using evaluation criteria established in the Act (ORS 459A.914(3)). DEQ issued a request for information; convened a technical workgroup; initiated discussions with producers, processors, and end markets; and is modeling

economic and environmental impacts. This work is ongoing and can be reviewed at https://www.oregon.gov/deq/recycling/Pages/Material-Lists.

DEQ's initial recommendations about placement of materials on different lists are summarized below. Many other materials are still under evaluation.
