





Oregon Impact Reduction and Reuse Program Overview

The Recycling Modernization Act requires DEQ to establish a program to reduce environmental impacts of covered products through activities other than waste recovery, such as waste prevention and reuse. Under ORS 459A.941, obligated producers of packaging, printed paper, and food serviceware will join producer responsibility organizations that will make specific and targeted investments including payment to a new 'waste prevention and reuse fee.' DEQ will use these revenues to establish the Oregon Impact Reduction and Reuse Program to fund activities that reduce environmental impacts of covered products. Statute caps the fee at 10 percent of the three-year average of the PRO's annual expenditures.

As the name of the fee implies, two methods of reducing environmental impacts of covered products include waste prevention and reuse. However, the program could potentially fund any activities that reduce environmental impacts that occur in the life cycle of covered products. This could include supply chain, production, transport, use, and disposal. Examples of projects or practices could include industrial efficiency or pollution prevention, the reduction of disposable dishware through infrastructure to support durables, material innovations, or other process changed aimed at reducing the impacts of covered products.

The fee will be established by Oregon's Environmental Quality Commission via rulemaking that DEQ will begin this summer. Programming is anticipated to begin in late 2026. DEQ is currently planning this work, seeking feedback, and generating ideas about potential projects that could be supported by this program. We are hoping to engage anyone interested in this work and are seeking feedback through a variety of methods including listening sessions.

Criteria to consider

- Funds must be used to reduce the environmental impacts of covered products. Covered products are
 defined as packaging, printing and writing paper, and food serviceware. Covered products do not
 include items outlined in 4594.863(6)(b). Funds cannot be used to reduce impacts of items that are
 not covered products, such as food, textiles or building materials.
- Environmental impacts can occur anywhere in the life cycle of covered products, including supply
 chain, production, transport, use, and disposal. Impacts can be reduced through changes in any of
 those life cycle stages, including but not limited to material substitution.
- DEQ may enter into agreements and may provide grants or loans to reduce environmental impacts
 of covered products. Entities eligible for a grant or loan include, but are not limited to:

Plastic Pollution and Recycling Modernization Act



• Effective Jan. 1, 2023

Includes updates to Oregon's recycling system

Oregon Impact Reduction and Reuse Program



Initial Feedback

Criteria

Funds **must** be used to reduce the impacts of <u>covered products</u> (packaging, printing and writing paper, and food serviceware) through means <u>other than recycling</u>.

DEQ may:

- Enter into agreements
- Provide grants or loans
- Must consider environmental benefits, human health benefits, social and economic benefits, cost-effectiveness, and needs of economically distressed or underserved communities.

Recycling Council recommendations process

Draft prepared for the June 12, 2023, Oregon Recycling Council meeting

This background document provides information about some actions required for the Oregon Recycling System Advisory Council under the Plastic Pollution and Recycling Modernization Act. This document proposes options for a decision-making approach and a suggestion for how the Council may submit recommendations.

Council role and responsibilities

As described in <u>ORS 459A 902</u>, the Oregon Recycling System Advisory Council has a formal role advising DEQ and Producer Responsibility Organizations on elements specified within the Plastic Pollution and Recycling Modernization Act. To date, DEQ has consulted with the Recycling Council on many topics during development of draft administrative rules and to establish initial elements of the system modernization efforts.

Recommendations

Starting in late 2023, DEQ will bring additional topics for Council discussion and will ask for recommendations. Recommendations may be submitted in writing and through verbal discussion and consultation at regular Council meetings, ORS 459A.902 does not require written recommendations from the Council except for "matters that the council determines are beneficial to the public interest". The statute includes specific examples of those matters, in addition to allowing the Council discretion to make its own determinations about other topics that would benefit the public interest and be best supported through a written recommendation to DEQ or the Producer Responsibility Organizations.

Options for decision-making approach

Timing and information flow

DEQ will prepare information and present topics at the Council's request.

- For some relatively straight-forward topics, the Recycling Council may be able to receive background information and finalize a recommendation in one meeting.
- For topics and decisions that are more complex, or when Council members have strong differing
 opinions, two or more meetings may be needed.

For all topics, DEQ staff will provide support and compile any draft written recommendations developed by Council members.

2. Are there recommendations on how a Council member could propose a written recommendation for a matter determined to be of public benefit that isn't otherwise specified in ORS 459A.902?
