# **First Rulemaking Process**

DEQ will present proposed rules for consideration by the Environmental Quality Commission on Thursday, Nov. 16. The proposed rules relate to the obligations of producer responsibility organizations, local government compensation, and recycling acceptance lists. Please note that the public comment period is closed and the Commission will not accept any testimony on the proposed rules.

The hybrid meeting will be held via Zoom and in-person at DEQ Headquarters in Portland. ## **Second Rulemaking Process**

The second rulemaking to clarify aspects of the Recycling Modernization Act is well underway. At its next meeting on Jan. 31, 2024, the Rulemaking Advisory Committee will discuss the fees the producer responsibility organizations will pay to recycling processors, covered product exemptions, and a few topics related to producer responsibilities. ## **Recycling processing facilities**

The technical workgroup related to commingled recycling processing facilities will meet on Dec. 4 from 12:00 p.m. to 4:00 p.m. to continue discussions about details related to the permitting and certification program as well as the two fees that the producer responsibility organizations will pay to the processors. #### Life cycle impact evaluation standards and methods

The Recycling Modernization Act requires producers to evaluate and disclose the life cycle impacts of covered products in some cases. Large producers, as well as all producers seeking to qualify for eco-modulated fee bonuses, will conduct life cycle evaluations.

DEQ is currently drafting standards and methods for producer life cycle impact evaluation. To seek additional input, DEQ is posting a second Request for Information, which will be open Nov. 16 through Dec. 15.
