Meeting Summary

12:30 pm Welcome

Chair Pam Peck welcomed everyone and did a role call. DEQ staff provided an overview of the Zoom platform and interpretation.

DEQ Update

Cheryl Grabham, DEQ Product Stewardship Manager, provided a high-level overview of the Recycling Modernization Act implementation. Several big projects have already been completed, including the Truth in Labeling Task Force and a technical workgroup for materials lists. The first of two rulemaking advisory committees is underway. Contracts are moving forward, and work has begun to start projects related to local government compensation, fees and permits for recycling processing facilities and reducing contamination in recycling.

Several more parts of the act will begin in the coming years, including the second rulemaking, an equity study, an evaluation of multitenant recycling, setting life cycle analysis standards, developing waste prevention and reuse grants and more. DEQ is confident about meeting all deadlines in the act and continues to hire staff to reach these targets.

Vice-chair update

DEQ staff reviewed the process for the first online vote taken by Recycling Council members and asked for feedback on the process. Dylan de Thomas said the process went well and thanked the staff.

Council members selected Celeste Meiffren-Swango as the next Vice-chair of the Council. Celeste thanked the members and said she was honored and looking forward to working as the Vice-chair. A breakdown of votes is at the end of this document.

Material lists information and discussion

- DEQ staff provided an overview of the difference between covered products, material acceptance lists and specifically identified materials. Council members had time to ask questions of staff.
- Staff then reviewed the evaluation criteria used to place materials on different lists.
- Two materials, a paper and metal can and expanded polystyrene, were discussed in more depth. Staff asked the Council for input on which list, if any, these materials should be placed and how to prioritize competing principles that these two materials illustrate. For the paper/metal can, comments generally supported including the can on the commingled recycling list even if some material is lost in the recycling process. Several members called for public education about how much of an item is recycled and asked to see the Sonoco recycling research. When discussing expanded polystyrene, several members noted the substantial public interest in recycling this material and the need to work toward a replacement, including durable/reusable options.
- Next, staff presented the proposed producer responsibility organization and local government recycling acceptance lists. Members brought up current market conditions, the desire to broaden the list of items accepted, the importance of simple messaging for the public and a request to think outside the box and make bold moves for the future.
- Due to time constraints, some conversations were cut short. Staff requested feedback via email by 11/3 on three specific topics:
 - High-level principles and their prioritization
 - Questions about individual materials (e.g., "what are the end markets for X?" or DEQ's recommendations (e.g., "why are you recommending acceptance of Z?")
 - Additional feedback, including information related to materials not vet recommended
 - Members can send input to Alex.Bertolucci@deg.Oregon.gov.
