

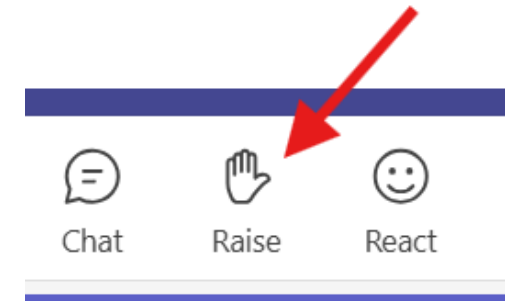

Mattress Stewardship Program

- SB 1576 - Creates a statewide system for collection and management of discarded mattresses
- Stewardship organization (MRC) develops and implements a program, under a plan approved by DEQ
 - Plan approved July 2024
- After plan approval, stewardship organization must implement within 7 months
 - MRC launched program Jan. 1, 2025
- DEQ provides oversight, technical assistance, enforcement

Meeting objectives

- The advisory committee meets annually to consult with stewardship organizations operating mattress stewardship programs and advise DEQ regarding:
 - The review and approval of any plan for the development and implementation of a mattress stewardship program submitted to the department under ORS 459A.159;
 - The review and approval of any amendment to a plan submitted under ORS 459A.168; and
 - **The review and approval of annual reports submitted by a stewardship organization**
