Pursuant to Oregon Administrative Rule 340-096-0310(1), all processed materials marketed by a CRPF must be sent to a "Self-Attested Responsible End Market" as defined in 340-090-0670(1) and (2). If you, due to circumstances beyond your control, affirm that no end market that meets Oregon's "Responsible" standard is available for a specific material, you must request an Acknowledgement Form from Oregon DEQ. This form temporarily allows the requesting entity to market processed materials to a Non-Self Attested Responsible End Market.

Instructions: This form is intended to be used by Brokers or Secondary Processors of Oregon-originating recyclable material. Complete one Acknowledgement Form for each end market you are intending to market materials to within 72-hours of sending an email notification to the DEQ. This form **does not** grant relief from reporting requirements listed in OAR 340-096-0300(8)(e) for reporting the final disposition of Oregon-originated recyclable material.

Send the completed Acknowledgement Forms to: deq.oregon.gov. DEQ will respond to a completed Acknowledgement Form within 72-hours of receipt. The approved Acknowledgement Form only applies to the material[s], end market, and up to the timeframe specified in the completed form.
