Welcome and review agenda

DEQ staff welcomed everyone to the meeting and discussed the purpose of the meeting.

Response to advisory committee feedback and questions from April 29th meeting

Oregon fire code

DEQ staff presented on proposed changes related to Oregon fire code.

There was no feedback from the advisory committee.

Environmental justice

DEQ staff discussed environmental justice requirements.

DEQ will continue to work with DEQ's Environmental Justice coordinator to ensure they are following State requirements and best practices.

DEQ agrees that the State is obliged to take into consideration the requirements set forth in ORS 182.545 regarding communities disproportionally burdened by pollution.

An element of the proposed draft revisions would allow waste tire storage to be in alignment with Oregon State Fire Code since waste tire program rules have not kept pace. This will help the program to be more protective of public and environmental health and reduce the potential impact of waste tire storage and the effects on communities most greatly affected.

The public will have the opportunity to comment on these topics in September during the public comment period.

A RAC member asked about the external requirements for DEQ to comply with these. Are these conditions enforceable only through individual permits or does the public have other ways to ensure that they are being met?

DEQ staff responded that they appreciate the question but will need to look further into this issue to answer the question.

Tire-derived materials

DEQ staff presented on questions regarding covering tire-derived materials.

There was no feedback from the advisory committee.

Review and feedback on draft fiscal impact statement

DEQ staff discussed the estimated <u>draft fiscal impact statement</u>.

Questions for RAC:

• Will the rule have a fiscal impact?

- What will the extend of that impact be?
- Will it have a significant impact on small businesses?
- What can DEQ do to reduce any adverse impact on small businesses?

A RAC member asked if there was a difference in the weight of consideration of feedback submitted RAC by Jun 15th vs public comment feedback submitted later? Does DEQ look at them differently?

DEQ staff responded that anything submitted by Jun 15th has the chance to be included in the proposed rules that are then set forth for public comment in September. However, DEQ will review those comments and may revise the finalized the proposed rules before they are sent to the EQC so all comments will be considered. From the EQC point of view, all comments and feedback are most likely to be considered equally.
