Upon consideration of the State of Oregon's ("Oregon") and the U.S. Environmental Protection Agency's ("EPA") October 28, 2024 Motion to Amend Final Order and Judgment (ECF 262) and the related filings, IT IS HEREBY ORDERED that the motion is GRANTED.

IT IS FURTHER ORDERED that the deadlines established by Paragraph 4 of the Final Order and Judgment (ECF 207); the Order Amending Final Order and Judgment (ECF 224); the

Order Amending Final Order and Judgment (ECF 255); and the Order of January 22, 2025 (ECF 268) by which Oregon is to submit and EPA is to approve or disapprove replacement temperature Total Maximum Daily Loads ("TMDLs") for certain waters that are the subject of the Final Order and Judgment are hereby extended. EPA shall complete its final agency actions approving or disapproving the replacement TMDLs by the dates listed below. Oregon shall submit TMDLs it establishes to EPA at least 30 days in advance of the dates, as listed below. The deadlines for such TMDLs are as follows:
