Wastewater Operator Continuing Education units

Beginning March 14, 2023, all wastewater operator certificate applicants will use Your DEQ Online to apply, renew, update or make changes to their certifications. Continuing education units approved by DEQ and the Oregon Environmental Services Advisory Council are offered for training on how to use the Your DEQ Online system.
