Ongoing Resource Parent Live Online Training Opportunities

ODHS Child Welfare coordinates a variety of live/online training offerings for resource parents, relative resource parents and adoptive/guardianship families. Training sessions range between 1-3 hours long and will be hosted on Zoom. All registration occurs by clicking the registration link and filling out a form – there is no need to create an account to request registration. At least one topic will be hosted each month with simultaneous Spanish interpretation. All topics can be counted toward ongoing training hours for recertification as an ODHS Child Welfare Certified Resource Family.
