Update on contingency funding

ODDS is extending contingency or retainer funding based on approval from Centers for Medicare and Medicaid Services. Discovery, DSA, Employment Path and Job Coaching included. Contingency funding will be issued in two thirty-day increments. The first 30-day increment will be based on June 1 – June 30, 2020 billing data. ODDS will compare average utilization for each service by individual for October – December 2019 to billings completed June 1- June 30 to determine funding, as outlined above and in the attachment. The payment will be for the funding period of July 15, 2020 – August 15, 2020. The second 30-day increment will be based on July 1, 2020 – July 31, 2020 billing data. The payment will be for the period of August 16, 2020 – September 15, 2020. For this reason, it is critical that billing for services rendered, including remote services, are billed as soon as possible and kept up to date.
