Re: Medicaid Reimbursement Rate Change

This is to inform you of a change to the daily Medicaid reimbursement rates for nursing facility services that was effective January 1, 2017. This rate change was made due to 2013 Legislative decision for the Nursing Facility Bed Capacity Reduction initiative. The rate changes were in accordance with Oregon Administrative Rules 411-070-0437 and 411-070-0442(3) for nursing facility per diem rate setting. Until the nursing facility bed capacity goal is met or June 30, 2020, whichever comes first, the nursing facility rate may be subject to change each calendar quarter. The Aging and People with Disabilities Medicaid Rate Schedule is posted at <http://www.oregon.gov/dhs/seniors-disabilities/Pages/index.aspx> under Provider and Partner Information – Rate Schedule. The daily Medicaid reimbursement rates for service dates beginning January 1, 2017 are as follows:

Basic Rate	\$281.28
Complex Medical Needs Rate	\$393.79
Pediatric Rate	\$540.98
