Topic: *New Tag* ~ C282 RN Delegation and Teaching

Historically, CBC OAR 411-054-0045(1)(f) or citation tag C280 has included Resident Health Services for the following areas:

- RN Assessment;
- RN Delegation and Teaching;
- Monitoring of Resident Condition;
- Participation on Service Planning Team;
- Health Care Teaching & Counseling; and
- Intermittent Direct Nursing Services

The CBC Licensing Office has determined citations within the RN Delegation and Teaching area should be uniquely identified to benefit provider communication and ongoing analyses of continuous improvement measures.

Effective July 1, 2016 there will be a *NEW* CBC citation tag C282 specific to RN Delegation and Teaching. The specific Resident Health Services citation tags and OAR will be therefore redefined as follows:

- 1) Tag C280 RN Assessment
411-054-0045 (1)(f)
 - (A) Registered Nurse Assessment
 - (C) Monitoring of Resident Condition

- (D) Participation on Service Planning Team
- (E) Health Care Teaching & Counseling
- (F) Intermittent Direct Nursing Services

2) *NEW* Tag C282 RN Delegation and Teaching

OAR 411-054-0045(1)(f)

(B) Delegation and Teaching. Delegation and teaching must be provided and documented by a RN in accordance with the Oregon Administrative Rules adopted by the Oregon State Board of Nursing in chapter 851, division 047.

Registered Nurses are required to follow both **Division 45 (Standards and Practice for Nurses) and Division 47 Standards for Community-Based Care RN Delegation and Teaching**. In deciding whether or not to delegate to (a) unlicensed paid caregiver(s), the RN must follow the nursing process (Div 45) and consider all required aspects of the Oregon Nurse Delegation (Div 47) process including caregiver teaching and supervision of a nursing task, while also completing thorough documentation of all required aspects of the rule for each individual resident and for each individual paid caregiver.

Additionally, it is recommended that the RN seek training on Division 47. There is a self-study course on RN Delegation for Community-based nursing available at:
