1. Summary of the care and services we provide.

Bonaventure of Medford Memory Care provides all state required services, including general assistance with activities of daily living, food service, which includes modified special diets as necessary, medication assistance, housekeeping services and social and recreational activities. We also provide transportation and the following additional medically related services: transportation is provided on designated days and within a limited mileage range

2. Summary explanation of the types of care and services we do not provide.

Bonaventure of Medford Memory Care does not provide the following services on a routine basis: We do not provide medically complex diets beyond the required modified special diets, complex wound care, behavior patterns unresponsive to interventions, support of those with significant mental health diagnosis, support of non hospice bedbound residents provided on a case by case basis, utilization of tube for feeding/medication administration, 1:1 care/companionship, assistance with PT directed home exercise plans outside of escorts to meal/activities and transfer assistance Describe any health, nursing, behavior or care service you want a prospective resident to know the community is unable to provide (*e.g., medically complex diets beyond the required modified special diets, two-person transfers, specific dialysis services, etc.*)

3. If your needs exceed the care and services we provide, we may ask you to move out.

When your needs exceed the care and services we provide, we will meet with you to discuss the circumstances, attempting to determine the most appropriate care plan and setting to meet your care and service needs. If we cannot properly care for you at our community due to your increased needs, we may ask you to move to a more appropriate setting. If an agreement is not reached and attempts to resolve the issue are not successful, we may give you an involuntary move-out notice.

4. If you leave our community to receive acute medical, psychiatric, nursing facility or other care, we will conduct an evaluation before you can return to our community. Before you can return to our community, a qualified staff person will re-evaluate your condition and determine if our community can continue to meet your needs. If we determine we can no longer meet your needs, we will issue you an involuntary move out notice and you will not be permitted to return to our community. We will notify you of this determination as soon as possible and before you leave the acute care or other setting.

5. You have the right to ask for an administrative hearing if you disagree with our decision to issue you an involuntary move out notice. The requirements for requesting a hearing can be found on the Administrative Hearing Request form MSC
