

Consumer Statement: Providence Brookside Memory Care

SUMMARY OF THE CARE AND SERVICES WE PROVIDE:

Providence Brookside Memory Care, provides all the state required services, including general assistance with activities of daily living; food service, which includes modified special diets as outlined in the Uniform Disclosure Statement; medication assistance; housekeeping services; and social and recreational activities. We provide transportation as outline in Uniform disclosure statement.

SUMMARY EXPLANATION OF THE TYPES OF CARE & SERVICES WE DO NOT PROVIDE: Providence Brookside Memory Care does not provide the following services on a routine basis: one-on-one care; medically complex diets such as renal, cardiac, carbohydrate controlled, weight control, specific caloric levels, vegan, gluten free, etc.; unstable and unpredictable diabetics, behavioral expressions that pose a threat to other residents or the staff; Residents must be able to complete a predictable transfer with a maximum of two person assist and must bear weight. We do not use mechanical transfer devices. We do not provide services that require skilled nursing such as, dialysis or care for medically complex diagnosis that require frequent nursing intervention or monitoring.

IF YOUR NEEDS EXCEED THE CARE & SERVICES WE PROVIDE, WE ASK YOU TO MOVE OUT: When your needs exceed the care and services we provide, we will meet with you to discuss the circumstances, attempting to determine the most appropriate care plan and setting to meet your care and service needs. If we cannot properly care for you at our community due to your increased needs, we may ask you to move to a more appropriate setting. If an agreement is not reached and attempts to resolve the issue are not successful, we may give you an involuntary move-out notice.

IF YOU LEAVE OUR COMMUNITY TO RECEIVE ACUTE MEDICAL, PSYCHIATRIC, SKILLED NURSING OR OTHER CARE, WE WILL CONDUCT AN EVALUATION BEFORE YOU CAN RETURN TO OUR COMMUNITY: Before you can return to the community, a qualified staff person will re-evaluate your condition to determine if our community can continue to meet your needs. If we can no longer meet your needs, we will issue you an involuntary move-out notice and you will not be permitted to return to our community. We will notify you of this determination as soon as possible and before you leave the acute care or other setting.

YOU HAVE THE RIGHT TO ASK FOR AN ADMINISTRATIVE HEARING IF YOU DISAGREE WITH OUR DECISION TO ISSUE YOU AN INVOLUNTARY MOVE-OUT NOTICE: The requirements for requesting a hearing can be found on the Administrative Hearing Request form MSC 0443. THIS IS HOW WE ARRANGE/COORDIANATE HOSPICE CARE: Providence Brookside Memory Care will work with hospice providers to both arrange and coordinate hospice care if you are your representative request it. We may suggest it, if we recognize the need. While we agree to arrange and/or coordinate, the choice of the agency is completely up to you.
