To: ODDS Stakeholders

Hello! We are making a change in how we send out important news to our stakeholders.

Currently, when important news goes out from ODDS, such as Director's Messages, we use an email list we manage internally.

On August 10, 2018 we are replacing that list with a better system, called GovDelivery. In this system you can subscribe and unsubscribe at will. You don't need to wait for us to take care of that for you.

The GovDelivery system also allows you to sign up for other email lists for the Oregon Department of Human Services and the Oregon Health Authority.

Given the high number of failed messages due to old emails or other problems in our current list we will not automatically subscribe everyone to the GovDelivery system.

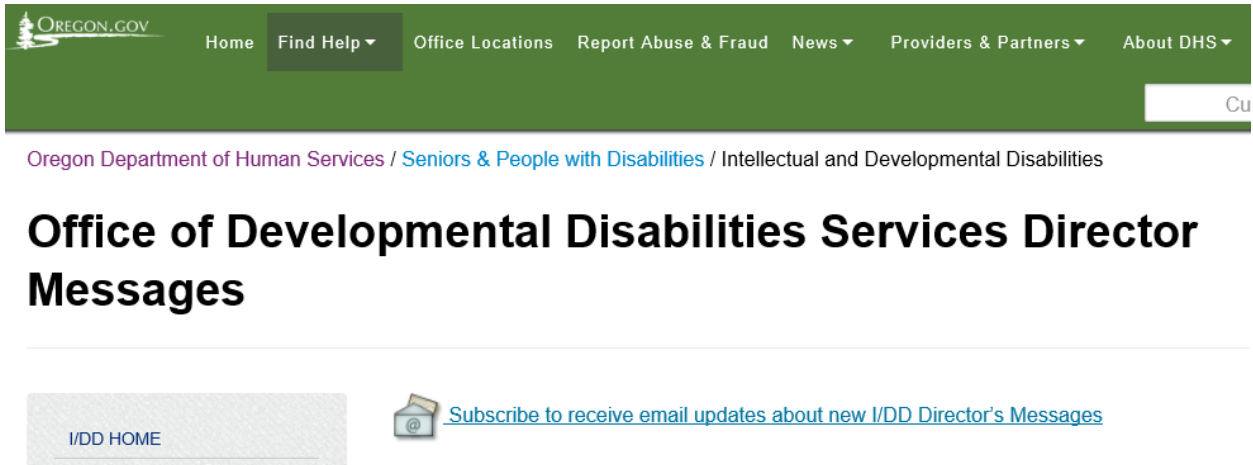

How to sign up for GovDelivery

Step 1

At <https://www.oregon.gov/DHS/SENIORS-DISABILITIES/DD/Pages/messages.aspx>, select the link “Subscribe to receive email updates about new I/DD Director’s Messages”
