Hello,

This message is to inform you about the statewide launch of Electronic Visit Verification (EVV).

A new federal law requires that states implement an electronic system for verifying attendant care services, called Electronic Visit Verification (EVV). EVV is required for all Medicaid attendant personal care services and home health services that require an in-home visit by a provider.

This will not impact your work or role as a common law employer or employer of record. EVV will be used by your Personal Support Workers (PSWs) who work for you to track their time, hours and services and will still provide you with a timesheet to be signed. What you and your family primarily need to know is that your PSW will have a new way of tracking their work time on their smart phones or tablets. This is called the eXPRS Mobile-EVV.

Statewide roll-out of EVV is **July 16, 2019**. PSWs will be required to use EVV for dates they work starting July 16.

In-home Medicaid services and supports delivered by agencies will be required to use EVV no later than January 2020.

Again, this does not impact services, but we wanted people who employ PSWs to be aware this is happening. Your employee, the Personal Support Worker, will be required to use the mobile EVV, but you are not required to do anything different. You will still need to sign time sheets as you have always done.
