Hello,

We want to let people with intellectual and developmental disabilities (I/DD) and their families know about a change to eXPRS called eXPRS Mobile-EVV, or Electronic Visit Verification (EVV).

A new federal law requires that states have an electronic system for verifying attendant care services in real time (at the time the service is occurring) from providers.

In Oregon, attendant care services for people with I/DD are services provided by Personal Support Workers (PSWs) and some provider agencies.

We are starting with a change to the eXPRS payment system which we are calling eXPRS Mobile-EVV for PSWs. EVV will be required for all in-home Medicaid attendant care and/or personal care services and supports when delivered by a Personal Support Worker for dates they work starting **July 16, 2019**.

In-home Medicaid attendant care and/or personal care services and supports delivered by agencies will be required to use EVV no later than January 2020.

This change to eXPRS will not impact your services. EVV will be used by Personal Support Workers (PSWs) for tracking their time, hours and in-home attendant care and/or personal care services. What individuals and families need to know is that PSWs will be using eXPRS Mobile-EVV to track their work time on their smart phones or tablets.

Again, this does not impact services, but we wanted people who employ PSWs to be aware of this requirement.
