A user must select the application type and follow portal generated prompts before submitting payment. Post March 1, 2022, the ODDS DD Licensing unit will no longer accept checks or money orders for Renewal Applications and New Home Applications.

Historically ODDS DD Licensing has accepted New Home application payments via check to the department and Renewal payments via an accounts receivable invoice. This new paperless payment portal will ensure payment security as well as ease of payment record access, our process has been modernized into this new portal.
