**Discussion/interpretation:**

The [Expenditure Guidelines version 12](#) has been updated to reflect a legislatively approved rate increase for Children's Residential Programs (SE 142). These rates are effective for all services beginning 9/1/2021.

Existing service agreements and ISPs that identify rates are not required to be updated. The eXPRS team has updated the rates in all applicable SPAs effective 9/1/2021. Please do not manually update rates at this time. Because rates have already been increased by the system, any changes to SPAs should align with the

expenditure guidelines. If you have questions about updating a rate, please contact your FAC.
