Message: As part of the Collective Bargaining Agreement (CBA) funds have been made available for one-time payments to DD Adult Foster Care providers who provided services to individuals with intellectual or developmental disabilities through the height of the COVID pandemic.

This one-time payment will be issued to DD Adult Foster Care providers who:

- worked as a DD Adult Foster Care provider serving Medicaid eligible IDD individuals between **March 1, 2020 and February 28, 2021**; and
- have an active provider number as a DD Adult Foster Care provider December 1, 2021.

The one-time payment is \$1,000.00 for each Medicaid eligible resident served during the dates noted above.

These one-time payments will be processed in eXPRS, under SE56 and issued automatically to DD Adult Foster Care providers who meet the above criteria. Providers do not need to take any action to receive this payment. Payments are

targeted to be released to providers the first week of December 2021.
