Message: As a result of the 21-23 Collective Bargaining Agreement for DD Adult Foster Care Providers, ODDS will be increasing rates for Adult FC services provided beginning July 1, 2021. DD Adult Foster Care providers will receive a **5%** rate increase retroactive for service dates starting July 1, 2021. This rate increase applies to the services outlined below.

The **5%** rate increase for DD Adult Foster Care services applies to:

- DD Adult Foster Care services **SE158-ORAF-NA**
- Attendant Care 2:1 staff support hours for Adult Foster Care providers authorized under **SE257-OR526-ZE** from \$14.09/hour to **\$14.87/hour**.

The rate increase ***does not*** apply to:

- Transportation services, such as **OR004-Mileage** SPAs or **SE53-TRFFS-ALL** CPAs
- DD Children's Foster Care services **SE258-ORCFC-NA**

ODDS will facilitate the implementation of this rate increase to existing POC Service Prior Authorizations (SPAs) through a systemized process **beginning on Wed 12/15/2021 to be completed by Monday 12/20/2021.**

Starting on Wed 12/15/2021, we ask CDDPs to not add or edit SPAs for Adult Foster Care providers, until after Monday 12/20/2021, as to not interfere with the rate increase process. If you have already added the increase to rates on 7/1/2021 or future SPAs please change them back, otherwise providers could potentially be overpaid.

After **Monday 12/20/2021**, CDDPs will want to review their SPAs for DD Adult Foster Care providers that have a start date of 7/1/2021 to ensure that the rate listed on the SPA accurately reflects the appropriate rate increase. CDDPs can then add any new SPAs for DD Adult Foster Care services, assuring that the SPA date ranges align with the rate increase effective dates, and that the correct rate is entered for the applicable SPA dates.

The rate table entries for DD Adult Foster Care services (SE158-ORAF-NA), Attendant Care 2:1 staff support hours (SE257-OR526-ZE) will be updated in eXPRS to facilitate this rate increase work.

CDDP staff entering POC SPAs for these services with date ranges that cross from 6/30/2021 to 7/1/2021 may receive a validation error, as the SPA date range crosses the rate entry date-break. That validation error information is:

If CDDP staff encounter this error when entering and/or submitting SPAs for services impacted by the rate increase, adjustments to the SPA date range(s) will be needed to align with the rate increase dates.

- SPAs with the pre increase rate should end on 6/30/2021.
- SPAs with the updated rate should begin on 7/1/2021 or later.

SPAs for DD Adult Foster Care services SE158-ORAF-NA or Attendant Care 2:1 staff supports SE257-OR526-ZE entered in eXPRS by CDDP staff after the rate

increase process has been completed, will also need to align with the applicable rate date ranges. CDDP program staff may need to break those authorizations by date range, using the applicable service rate for each date range separately.
