Discussion/interpretation:

The [Expenditure Guidelines Version 13](#) has been updated to reflect a rate increase for hourly 2:1 attendant care services for Adult and Children’s Foster Care. These rates are effective beginning 4/1/2022.

Existing service agreements and ISPs that identify rates are not required to be updated. The eXPRS team has updated the rates in all applicable authorizations effective 4/1/2022. Please do not manually update rates at this time. If you have questions about updating a rate, please contact your FAC.
