Attention Case Management Entities:

Pursuant to a budget note included in the 2021-23 budget, the Oregon Office of Developmental Disabilities Services (ODDS) is in the process of studying the funding structure for case management services. Burns & Associates, a division of Health Management Associates (HMA-Burns), has been contracted to assist with this rate study.

A key element of this study is a provider survey that collects information regarding CMEs' service designs and costs.

- Data collected through the survey will be a consideration as ODDS assesses the adequacy of the current funding structure for CMEs. Thus, all CMEs are expected to participate.
- Partially completed surveys will be accepted however we ask that you do your best to complete all areas of the survey. You may skip any questions that request information that your organization cannot provide, and those portions of the survey that are completed will still be part of the survey analysis.
- All financial data should reflect your organization's most recently completed fiscal year. If there have been substantial changes in costs since that time, please describe these changes when submitting the survey. Additionally, if there are any factors that you believe should be considered but were not included in the survey, note those issues in the transmittal email when submitting the survey. You may also submit any other documentation that you would like considered as part of this study.
