Discussion/interpretation:

Effective 07/01/2022, ODDS will have a new rate for 1:1 (“Solo”) Employment Path Services. The new Worker’s Guide for [One to One “Solo” Employment Path Services](#), also effective 07/01/2022, is being published to outline additional guidance and implementation requirements. These requirements are in addition to existing requirements for ODDS Employment Path Services.

This service may include time limited support to participate in community work experiences, internships, time limited volunteer work experience, job shadowing, informational interviews, resume building, etc.

This service must be used in an integrated community setting to gain work experience. It cannot be used for support to gain work experience at a provider site. The work experience must be individualized and cannot be in a group.
