Action required:

Effective 01/14/2022 ODDS will **only require** submission of COVID-19+ and presumptive **individuals** who are receiving developmental disabilities service.

ODDS is **ending** the requirement for reporting COVID-19+ provider staff, CME staff and PSWs **to ODDS. This does not affect public health reporting requirements.**

ODDS encourages providers, families, and individuals to continue to report positive staff and residential program COVID-19 outbreaks to their respective CMEs in order to continue collaboration and monitoring of all individuals who may be impacted by a provider who is ill or who must quarantine and isolate.

The [ODDS COVID-19 Scenarios Tool](#) will be updated and posted to the ODDS COVID webpage on 01/19/2022 to reflect the changes announced in this updated AR. It will clarify information that must be included in the notification to: ODDS.COVID-19ScenarioReporting@dhsoha.state.or.us and others and under what circumstances

Reason for action:

ODDS has heard from Case Management Entities (CMEs) and providers that the ongoing reporting of COVID-19+ staff is taking away valuable time in coordinating the care for individuals. In reviewing the input and recommendations from the above listed entities, ODDS has made the determination to only continue to gather data on individuals being supported.
