Foster Care Service Rate COLA (AFHs Only)

As part of the 2019-21 Adult Foster Home Collective Bargaining Agreement (CBA) between the State of Oregon Department of Administrative Services and The Service Employees International Union 503, effective July 1, 2020 Adult Foster Home providers will receive a 7.15% Cost of Living Adjustment to individual service rates. ODDS will adjust the current service rates in eXPRS SE158 -ORAF-NA Plan of Care. (see [APD-IM-20-059](#))

The Adult Foster Home Support Needs Assessment Profile (SNAP) has been updated to incorporate the rate increase. Effective July 1, 2020 assessors must use SNAP version v20.07A which can be found at: <http://www.dhs.state.or.us/spd/tools/dd/cm/>

Foster Home 2:1 Attendant Care Rate Increase

For children and adults who have approved 2:1 attendant care, the hourly rate will increase 7.15% from \$13.15 to \$14.09.
