The following represent comments made by individuals completing the HCBS Individual Experience Survey. The following comments were made in the margins of the questions designed to get at an individual's ability to have homelike access within setting.

Some themes include:

- Most responses on Lack of kitchen access

30. I have full access to the following areas where I live any time I want or need: kitchen; dining room; living/family room; bedroom; and bathroom.
