**NEED FOR THE RULE(S)**

OAR 291-001-0020 through -0080 establish the department's policy on rulemaking procedure. These revisions:

- add Corrections Ombudsman and Nine Tribes to the required for notice list;
- add a new rule, OAR 291-001-0023, around requests from the public to receive rulemaking notices that align with new process (signup through website);
- provide correction (update old mailing address, fix rule reference), clarification and consistency within the rules, and remove unnecessary or redundant language; and
- update and reorganize OAR 291-001-0080 regarding requests for copies to align with current process and for clarity and to add a fee schedule for paper copies.

**STATEMENT IDENTIFYING HOW ADOPTION OF RULE(S) WILL AFFECT RACIAL EQUITY IN THIS STATE**

The Department of Corrections anticipates that the proposed amendments to its Division 001 rules, OAR 291-001 Procedural Rules, will have a neutral impact on racial equity in this state.

The Department of Corrections' Division 001 rules adopt by reference the Attorney General's Model Rules for Rulemaking, OAR Chapter 137, Division 1, and establish the department's policy, procedures, and standards for rulemaking procedures; requests to receive rulemaking notices and for copies of the department's notices of proposed rulemaking, temporary rules, and permanent rules; and for confidentiality and inadmissibility of mediation communications, including those concerning workplace interpersonal disputes.

Among the proposed amendments to the rules are the addition of Corrections Ombudsman and the nine federally-recognized Tribes of Oregon to the department's notice list; the addition of a new rule (OAR 291-001-0023) around

requests to receive rulemaking notices that aligns with new process (signup through website) and further defines this process; an update to the mailing address and correction of a rule reference; and changes for overall clarification and consistency within the rules.

Another proposed change to these rules updates and reorganizes OAR 291-001-0080 regarding requests for copies of rulemaking notices to align with current process and for clarity, and to add a fee per page for printed notices of proposed rulemaking, temporary rules, or permanent rules rulemaking notices. The department sends notifications of rulemaking electronically to interested parties and the agency posts notices of intended action on the department's website. For persons requesting printed and mailed copies of the proposed rule and other required information, the agency provides a reference to the website where electronic copies of the proposed rule and other required information are posted.

These proposed changes are not anticipated to have an impact on racial equity in the state.

#### FISCAL AND ECONOMIC IMPACT:

Rule 291-001 is updated to clarify mailing options by distinguishing postal from electronic mail, align with ORS standards, and expand notifications to include specific stakeholders like the Corrections Ombudsman and tribes. They streamline the process for accessing and requesting rulemaking notices, introduce online access options, add fee structures for printed materials, and incorporate provisions for fee waivers or reductions.

The rule change would introduce a nominal fee for printed rulemaking notices, charging \$0.12 per side for printed copies and including the cost of postage. Due to the varying number of notices sent each biennium and the uncertainty regarding how many individuals would transition from printed to electronic copies, it is difficult to determine the precise fiscal impact of this rule change. Consequently, the proposed changes are expected to have an indeterminate fiscal impact on the Department of Corrections (DOC), Adult in Custody (AIC) services, other state agencies, local governments, and the general public.

RULE SUMMARY: Amends rule to clearly distinguish postal mail from other options; add clarifying statutory reference; add Corrections Ombudsman and Nine Tribes to mailing list; and delete (2) as redundant and covered in (1).

(2) Any person may request to be included in the department's postal mailing list to receive notices of proposed rulemaking by sending a written request to the Department of Corrections Rules Coordinator via postal mail at 3723 Fairview Industrial Drive SE, Suite 200, Salem, Oregon 97302 or by sending a written request through the department's website at <https://www.oregon.gov/doc/rules-and-policies/Pages/Sign-Up-for-Rulemaking-Updates.aspx>. Persons requesting paper copies of the department's notices of proposed rulemaking shall be required to pay fees before materials are mailed. ~~(1) Individuals or organizations~~A person may request paper copies of the department's permanent or temporary rules, shall be required to prepay fees in accordance with notices of proposed rulemaking, temporary rules, or permanent rules by sending a written request to the Department of Corrections Rules Coordinator via postal mail at 3723 Fairview Industrial Drive SE, Suite 200, Salem, Oregon 97302 or by submitting a written request through the department's rules on Release of Public Records, OAR 291-037.
