According to reports, the **Macy** mine on Maiden Creek 11 miles northwest of Richland, Oregon, has been acquired by William Furze of Wardner, Idaho, president and general manager of the Ten-Said Mining and Milling Company; Thomas A. McBride of Kellogg, consulting engineer for the same company and surveyor for the Bunker Hill and Sullivan interests; and Cliff Harris and Kenneth Kobs, both of Kellogg. The new operating group is said to be installing a small milling plant. The mine is owned by George V. Whittle, 1823 Smith Tower, Seattle, Washington, and until recently was under lease to Glenn and Lloyd Anderson of Richland and W. C. Fudge of Seattle. The new operators are extending the crosscut to open a known vein at a depth of 150 feet.

A 10-ton mill is under construction at the **Macy** mine on Maiden Creek 11 miles northwest of Richland, Oregon. Additional mining equipment is also being installed to replace that lost by fire last fall. Glenn and Lloyd Anderson of Richland, and W. C. Fudge, 6125 Arcade Building, Seattle, Washington, are the operators. George Whittle of Seattle owns the property.

MORE POWER TO THEM

The success that is being gained at the Macey mine near Baker is an illustration of what can be accomplished in working some of the smaller mines of Baker county. The Macey has produced between \$25,000 and \$30,000 in gold working a small crew of miners. The ore being treated at the rate of about 10 tons a day is running between \$40 and \$50 per ton, and a recovery of 92 per cent of the values is made.

Another small operation is that of Frank Hancock near Granite where he is making a success with a small cyanide plant treating ore from the New York property.

The Hidden Treasure, about 10 miles east of Baker, is another of these properties which is proving profitable operating with a small force.

These are not considered as "big properties" in the present stage of development, but are doing well and as the work progresses may become of greater size and increase their production.

There are doubtless many other such opportunities in Baker county mines. More attention is being turned to such properties and they are playing a large part in bringing back the mining industry of Eastern Oregon.

Milling equipment at the **Macy** mine which was destroyed by fire last fall is being replaced by Glenn and Lloyd Anderson of Richland, Oregon, and W. C. Fudge, 6125 Arcade Building, Seattle, Washington. The mine, consisting of 12 unpatented claims, is 35 miles east of Baker in Baker County and is owned by George V. Whittle, 1823 Smith Tower, Seattle. The plant which was destroyed consisted of a 25-ton ball mill, which was not badly damaged, crusher, amalgamating equipment, Diesel engine, and compressor.

Milling is scheduled to be started at the Macy mine 11 miles northwest of Richland, Oregon, around August 1. The property was recently taken under bond and lease by Thomas A. McBride, Cliff Harris, and Kenneth Kobs, all of Kellogg, Idaho, and Louis Chesnick, Box 784, Baker, Oregon. Deeper development is planned for the mine, the first step of which will be to continue a 140-foot crosscut to a length of 530 feet. The crosscut, which opens the property 335 feet below the upper workings of the mine, disclosed an unknown vein and the continuation is expected to further explore and develop the ore.

LEASERS ARE MAKING GOOD AT THE MACY

97 Ounces Gold Shipped
to U. S. Assay Office

About \$3000 or 97 ounces of gold was the value of a gold brick from the Macy mine, shipped yesterday from a week's cleanup of the mill.

This is from the little Macy mine, a property about 35 miles east of Baker near the Baker-Homestead highway. The mine is making one of the most remarkable records of the smaller properties of the county.

The Macy mine is now being operated by the Maiden Creek Gold Mining company. The mine was taken over by George V. Whittle of Seattle, on a lease and bond from Loyal Young. Mr. Whittle in turn has given a lease to Kenneth Grabner and Lloyd Anderson.

The mill on the property is being operated by the leasers and from 75 to 100 tons of ore is milled each week. The value of the ore is approximately \$40 per ton, and a recovery of 92 per cent of the value is attained by the mill.

Weekly bars of bullion are shipped to the United States assay office at Seattle. W. C. Fellows, is the engineer directing the operations.

This in brief is the operation of a mine that has been worked intermittently for a number of years, but in the past few months with the systematic development that has been carried on it has come into active production and as the work progresses indications of increased production will be continued for some time.

Macy Mine is Opened With 11 Men Working

RICHLAND, June 8.—(Special)—

The Macy mine, known as the Maiden Dream gold mine, located 12 miles west of Richland, has been opened. The operators are making weekly shipments of gold bars through the First National bank.

The property has been sub-leased to Kenneth Grabner and Lloyd Anderson. Both the mine and the mill are running two shifts, with about 11 men employed. W. C. Fellows of Baker is doing the engineering work at the mine.

The amalgamation process is being used in the mill. No base ore has been encountered.

Macy Mine Now Weekly Producer

A new gold producer for Baker county got into good swing this past month when the Macy mine, now known as the Maiden Dream gold mine, 37 miles northeast of the county seat on the Halfway highway, began a steady weekly shipment of gold bars through the First National bank.

Last week the small mill ran through 127 tons of ore and produced 111 ounces of \$40-865 fine gold which indicates that the ore runs a little less than \$30 to the ton.

The property belongs to the Loyal Youngs and is under bond to George V. Whittle of Seattle and a sub-lease to Kenneth Grabner and Lloyd Anderson. Both the mine and the mill are running two shifts with about 10 men and the cook employed. W. C. Fellows of Baker is doing the engineering work at the mine.

Mining is being done in diorite, the silicious gold ore being taken out the tunnel level with sinking of the shaft at the 75-foot level continuing in order to block out the ore body even further.

The amalgamation process is being used in the mill and no base ore is encountered as yet.
