Dear Mr. Dole:

I have been so busy in the last two years, flying uranium grids in New Mexico, Arizona, Colorado and Utah that I have not been able to find time to write you a letter, more or less to apologize that I was not on hand to fly you or your geologist over the south eastern part of Oregon you wanted to see from the air. I will be available, though, next spring and summer, as, of course, I will be in the Steens Mountains.

I am enclosing with his letter our geological report on our Pike Creek uranium property, made by Mr. W. P. Johnston, knowing that you and Mr. Johnston are good friends and that Solar X Corporation has completely taken over the Dewey Quier properties. This report will be of interest to you. You have my permission to reprint or use part or all of this report in your Ore.-Bin publications.

At present, our crew is living and working on the property, cleaning off the excess shale and debris, making preparations for our spring work, which, of course, will be done as recommended by Mr. Johnston's report.

I might mention as a matter of personal interest that the pilots for Solar X, which includes myself, have completed 1,151 hours of flight time, flying with scintillators 10 to 50 feet off the ground in five western states. We have made 22 discoveries, of which two others besides the now acquired Pike Creek property, show possibility of commercial ore. We intend to push forward the Steens Mountains properties because they are the most accessible and would be the easiest to mine.
