

It has been brought to my attention that there is a mine called the "Little Arctic" some 18 miles from Grants Pass (direction unknown) which is 600' wide and averages some \$2 or \$3 in gold, besides some platinum.

Dear Mr. McGinnis:

I wish to acknowledge receipt of your letter dated January 31 concerned with the Little Arctic mine, some 18 miles from Grants Pass.

This property is listed in our Jackson County Mines Catalog as the McTimmons prospect in sec. 19, T. 33 S., R. 4 W. It is located on King Mountain and according to reports in the press some work was done in 1948. The reputation of the property has been that of being high-grade - that is, some spectacular specimens of free gold have been obtained. I had not known that there was a very large deposit of low-grade gold ore which would assay two or three dollars. I am asking our field geologist, Mr. Harold Wolfe, at Grants Pass to inform me if he knows of any development work and sampling at the property which would warrant information which you have received concerning the large low-grade deposit.

The description of the property in our Bulletin 14-C on Jackson County is rather meager and it would hardly pay you to buy this bulletin in order to get this mine report. I quote from the principal paragraph as follows:

"It is reported that this prospect has been worked by McTimmons and associates during summer months. A shaft 45 feet deep has been sunk. Ore is said to average 1.5 ozs. gold to the ton. Equipment consists of a 16-ton ball mill, a concentrating table, and a small compressor."

The above report was written in 1940. As you may know, the property is owned by Mr. Bert McTimmons of Grants Pass and Mr. Chauncey Florey, Box 26, Medford.

I have very lettle to add in the way of information on the Little Arctic mine (Mc Timmons mine).

The Property was leased (presumably with option to ouy) lest year by the cuady Mountain mining Company, 711 mutton Blag., Spokane. When I visited the property last october, the operators were not present and the wormen were reluctant to pass out any information. Apparently the new operators went on the property saily last spring. They drifted into the serpentine following a narrow zone which was very lich with "smeared" gold. The entire mass of serpentine is reported to carry some gold.

The workmen thought that they would be back on the property in the spring to do some arilling, but it may be that the company decided later to drop the property as ar. McGinnis mentioned in his letter.

Gentlemen:

The State Board of Forestry is in the process of acquiring a nonexclusive right of way across the Southwest quarter of Section 8, Township 33 South, Range 4 West, Willamette Meridian, Jackson County Oregon.

The right of way requested is thirty (30) feet in width on an existing road with the right to bury a one (1) inch power cable, eighteen (18) inches below the surface on the thirty foot right of way.

The owner, through his attorney is objecting to the States request. One of his objections being, that this area contains valuable mineral deposits, and the State use would interfere with the developments of these deposits.

Would it be possible for your department to appraise mineral value of the Southwest quarter of Section 8, Township 33 South, Range 4 West? It is my understanding, that there is one or two mineral claims upon this property, and that there is some development work on the claims.

Would it be possible to have a report upon this property in this office by April 30, 1962%
