Courf Rules Mine Work Stipend Legal

Salem. March 29 UPA suit by Robert S. Bairey arents Rose Opp and John W. Opp 16 their \$10,000 for work-done on the Opp in the \$10,000 for work-done on the Opp in the part Jacksonville, which resulted in favor of Bailey, was upheid by the state supreme court today.

Opp and Mrs. Opp claimed the contract by Bailey had not been completed, and further alleged that Opp, who made the contract with Baliey, was not the authorized agent

of his wife, who owns the property.

The mine, now being operated by Pacific States Mining company, has produced considerable gold, and Bailey sued to collect out of the revenue. Today's court ruling upheld Circuit Judge Harry D. Norton's opinion in favor of Bailey.
