I have never examined the above properties, although I have been in the immediate neighborhood several times. In fact, passed through that district on my way to the Blue Ledge Mine last month.

Re: CARBERRY PLACER PROFERTY

The writer will not attempt to make a report upon this property for the reason that he is only prepared to give you a Summarization of the salient features furnished by the owners as he has not visited the mine.

PROFERTY: The property is located near Browntown,
Josephine County in the
Steamboat Mining District (on Carberry Creek),
approximately fifty miles southerly from Grants
Pass, the County Seat of Josephine County, Oregon.

CLAIMS: The property contains sixteen mining claims of twenty acres each. Carberry Creek, which carries a steady flow of water the year around, passes through what would practically be the center of the property. This stream at times is thirty to forty feet in width and during the mining season would be three to four feet in depth. A head of approximately 300 feet would be provided by this stream and the grade of the areas is such that favorable locations are provided for the installation of large sluice lines. At all times sufficient grade is available so that the proper pitch of the boxes may be provided - a very favorable situation developed since it is a rarity to find water for practically the entire year's operations and then to find the gravel areas carrying

a grade that will provide the proper pitch for economic hydraulic installation.

GRAVEL: The depth of the gravel is reported as averaging approximately fifteen feet in depth. No cement appears to be found in the gravels. Most of the rocks are of such a size that they will readily pass through the ordinary sized sluice line but naturally there would be some large rocks present as the large nuggets formerly found would indicate the presence of some larger rocks.

BEDROCK: The bedrock is reported to be partially slate and greenstone materials.

However, with the amount of water present where a six-inch nozzle may be used either a smooth or rough bedrock would be immaterial.

DITCHES: There are ditches on both sides of Carberry Creek, each approximately one and one-half miles in length. These ditches are in bad repair and would have to be cleaned and repaired before same could be placed in general use. However, the cost would not be exhorbitant.

YARDAGE: Estimated gravel yardage - fifteen million cubic yards.

VALUES: The owners of this property apparently are very conservative in their statements since they quote .30¢ per cu. yard as the values contained in these gravels.

The information received from outside sources is that the gravel will run as low as .20¢ at different places but that much of the bedrock will carry from .50¢ to several dollars per yard and that some of the largest nuggets in the state have been found in these deposits.

TRANSPORTATION:

The location of the property is three miles

from the highway over a good trail. A road, however, is reported to have been started by the CCC operations that should be completed during this coming season.

OPINION: It is the writer's opinion because of having received the above information from reliable sources that the Carberry Placers, which are in excess of five miles in length, are practically the outstanding Placer areas of Josephine County at the present time, the main reasons being - abundance of water, type of gravel and bedrock, consistent commercial values, and, above all, there is an opportunity most years to operate the mine twelve months of the year - a rarity in Placer mining operations.
