On October 16, 1986 I learned that a group of local residences have retained an attorney to appeal the U.S. Forest Service' decision to approve an operating plan for a mining site(s) in Jackson County near Shady Cove. The USFS procedures allow a maximum of 45 days for consideration of the appeal by the Forest Supervisor. It will be important to coordinate our permitting and bonding activities for this operation with USFS personnel. The appeals group is alledging that the proposed mining site does not contain gold values.

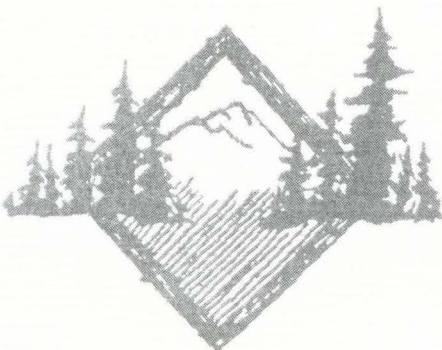
