Location: On Brush Creek. 7½ miles N.W. of Copper and 38 miles S.W. of Medford. It is in the N.E.½ of N.W.½ and N.½ of N.W.½ of N.W½, Sec. 21, T. 40 S., R. 4 W.

Area: Three 20 acre placer claims held by location.

History: These claims were the ones owned by Messrs. Akers and Waldens. Brush Creek has been worked by hand the last few years. The present owner has not done any work on the property.

General Information: Greenstone bedrock. Lots of small boulders. Not sufficient water to efficiently work the property. Gulch operation. Mountainous topography. No equipment. Elevation 2400 feet. Maximum 3 feet of snow.

Location: On Brush Creek $8\frac{1}{2}$ miles northwest of Copper and 39 miles southwest of Medford in the east one-half of the N.E. of the S.E. , Sec. 17, T. 40 S., R. 4 W.

Area: One 20 acre placer claim held by location.

Geology: Rough Andpsite bed rock. Placer gold comes from quartz ledges further up Brush Creek. Gravel varies up to about 5 feet thick and in some places some over burden. Lots of big boulders and some clay in spots. Coarse gold. A large nugget was found above this property last winter.

General Information: All hand work. No equipment. Maximum 4 ft. of snow. Water from November to June. Not enough water available to put in small giant. Gulch operation. Steep mountainous topography.

North Central Claim (gold quartz)

Owner:

Gerald Buck, Jacksonville, Oregon.

Location:

On ridge between French Gulch and Squaw Creek. 30 miles southwest of Medford in Sec. 31, T. 40 S., R. 3 W. No road to property. Approximately one-half mile by trail northwest of old Pacific States Mines.

Area:

One full sized quartz claim held by location; 20 acres.

History:

Located by present owner in 1926. Yearly assessment work is the only development work which has been done.

Geology:

Pyrite and chalcopyrite occur in schist as replacement bodies. General strike of vein is N. 45° E. and has about a 75° dip. Ore shoot replacement bodies are very small and no commercial tonnage is yet developed. The owner has never had any assays made.

Misc. Information: Elevation 2400 feet. No water. Plenty of timber. No equipment. Steep Mountainous topography. About four feet of snow.
