In reply to your letter of April 20, 1949 concerning mining claim Grubstake, the records at the Josephine County Clerk's Office at Grants Pass show that the assessment work on Grubstake claim is filed for 1945 and 1948, but for years between 1945 and 1948.

This office does not keep the records of claims, but only records of mines and prospects that have produced in the past or are producing now. The County Clerk's Office keeps the legal records on claims and the proof of labor on claims. For more detailed information apply to that office, please.

As a result of some brief work on my part at above mentioned office, the claims "Aunex" and "Grubstake" do not appear to be the same, but may overlap in part.

Description of "Aunex" is:

NE1, SE1, SW1, sec. 36, T. 36s., R 8w., Josephine County ---NE1 Lot 10.

Description of "Grubstake" according to an amended location of 1934 is:
No Lot 10 and E4, SW4, SW4 sec. 36, T 348; R Sw.

filed in 1928 by Colmof, the claim "Grubstake" was original by location have been recorded since. According to a quit claim deed, Mrs. Otis obtained possession of "Annex", but the name Aunes is not mentioned. The description of the location of

Aunex is mentioned in this deed, however.

The search of the records that I made was hurried and brief, so it should be necessary for a lawyer or abstractor to solve the mystery more accurately.
