Description of Prospect: The quarry on Quartz Creek road is in Galice sediments consisting of black slate. The slate contains numerous narrow calcareous veins parallel to the direction of the slaty cleavage, which strikes N. 10° E. and dips 55° S.E., as well as minor stringers transverse to the cleavage. Some of the calcareous veins contained pyrite and the largest one exposed in the quarry face was only 2 inches wide. A channel sample (MG-515:P-13774) from this seam assayed .01 cunces of gold per ton. A chip sample (MG-516:P-13775) across 35 feet of the width of the quarry did not carry any gold.

Mr. Hill reported that he had an assay from this quarry by Charles
