FALL CREEK COPPER PROPERTY

On 9/11/74 and 9/19/74, I visited and sampled the Fall Creek Copper prospect with the owner Robert (Bud) Cornett. The property is located about 9 miles down the Illinois River from Selma, Oregon. The road is narrow and winding in places, and the river must be forded so the property is only open during the summer and early fall months. Weather is not prohibitive to year-round operation.

The property is in serpentine surrounded on three sides by basic flows, tuffs, and agglomerates of the Galice Formation. Shearing, faulting, and folding are the prominent structural features.

Mr. Cornett staked his claims after the Oregon Scenic Rivers Act became effective, so a portion of his claims are invalid. The area is now being considered for part of the National Wild and Scenic Rivers program, and it seems certain that it will be affected as a area under the classification of Scenic River. Thus, mineral location will have to be persued through the Minerals Leasing Act.

A road four to five miles long will have to be built to avoid the river itself. Most mining activity could be carried out, out of sight of the river so mining would be possible under the Scenic Rivers Act.

The deposit might be as large as 90,000 tons with the grade possibly as high as 11 - 13% Cu. However, the old story of no market for direct shipping high grade ore or cons kill most hopes for producing from a property of this size.

I recently observed your mining claim notice posted on the Fall Creek Trail near the Illinois River. It is advisable for me to inform you of public law and Forest Service policy concerning the location of mining claims near the Illinois River.

On October 2, 1968, the Congress of the United States passed Public Law 90-542. This law provides for a National Wild and Scenic River System. Among its provisions is one that controls the location of mining claims along the Illinois River. The provision effectively withdraws the Illinois River from mineral entry. In other words, any claims filed on the Illinois River after October 2, 1968, are null and void. The area withdrawn from mineral entry is the bank and all land situated within 1/4 mile of the bank of the river.

I hope you will understand that, as the agency responsible for the administration of the National Forest and of the Illinois River area, we must be sure that all activities are in accordance with the law.

If you have any questions, please come to see us so we can discuss the matter.

I have now taken the time to read all of the correspondence which you gave me regarding your Fall Creek copper property and I regret that I have to agree with the negative position taken by both Ranchers and American Selco. In spite of the fact that the property could well be of economic interest, even if only as a small, high grade operation, the problems created by its location within the Illinois River scenic corridor would far outweigh any other considerations. Furthermore, in reading through the correspondence, it would appear that part of the area which you located had already been withdrawn from mineral entry and your title, therefore, would be at best dubious until the matter had been resolved through litigation.

In view of the above, I do not feel that it would be in my client's best interest for me to even look at the prospect. I hope you can understand my position in this matter and I do want to thank you again for bringing the property to my attention.

Subject: Prospecting and mining adjacent to and within the Illinois River Scenic Waterway

I'm writing on behalf of myself and the Ranchers Exploration and Development Corporation from New Mexico, to secure a permit to explore mining claims located near Fall Creek, Section 4, Township 38 South, Range 9 West, Josephine County. The proposed exploration is to drill three holes in order to determine whether a commercial copper are body exists. We also need assurance that we can mine the are if it is found in commercial quantities. We are prepared to comply with the necessary regulations to preserve scenic and environmental qualities of the area.

We are enclosing a plat and a map to show the locations. You will notice, part of the claims extend inside the Scenic Waterway & mile corridor. Three small X's have been placed on the map to pinpoint the proposed drill sites. Also please note that all drill sites are not visible from the river as they are on the south side of the ridge. Two of the proposed drill sites are within the quarter mile zone and the other one is outside the area.

I have had these claims continuously since 1969, and have used and maintained the existing "jeep" road during this time. We need your permission, however, to use the road temporarily to transport the drill rig in and then back out again. It is clearly understood by Ranchers and me that any disturbance of the surface or vegetation within the ¼ mile corridor be avoided or kept at a minimum in order to preserve scenic values.

With your permission to drill and mine the ore if it is there, we plan, again with your permission, to build another road to supply unseen access to the property. This road will be completely outside the withdrawn zone and will offer year round operation for the mine. It is to connect Fall Creek to a Forest Service road, which is three miles to the south. If this can be accomplished we propose, with your approval, to abandon the existing road and if needed revegetate the surface, thus removing any scars that can be seen from the river.

The prospect, if it becomes a mine should lend itself to underground operation which will cause very little disturbance of the surface. Any disturbance can be filled in and natural vegetation replanted by the operators. We expect no water or air pollution to accompany the operation. We plan to ship the ore to an out-of-state smelter and will not attempt to concentrate it on the premises.

I have now completed evaluation of the data collected during my recent examination of your Fall Creek copper property and wish to inform you that American Selco will take no further action there. I believe the prospect has the potential to support a relatively small, high-grade mine, but there simply does not appear to be sufficient evidence that the known zones can generate sufficient tonnage for the size operation of interest to our Company. Although the unresolved "Wild River" problem obviously affects our decision, we might be willing to face this if the target were sufficiently attractive.

Subject: Illinois River, Mining Within

the Protected Corridor

As I understand it, all USFS lands within one-fourth of one mile of the Illinois were withdrawn from mineral entry pursuant to PL 90-542, the National Wild and Scenic Rivers Act, which the Congress passed in October 1968. The withdrawal stands until completion of the Federal study, now under way, to determine if the Illinois should be added to the National Wild and Scenic River System. Another act of Congress would probably be required to alter the withdrawal. Frankly, I think that is not feasible at this time.

The USFS expects to present its study to the President and Congress in about two years. I don't know what the outcome will be, but I will be surprised if the USFS doesn't recommend inclusion of at least as much of the river as the State covers with the Oregon Scenic Waterway. Congressional action will determine finally how much of the river, if any, is included.

Meanwhile, I think there is very little the state can do in this matter. We cannot direct the Federal management of USFS lands. Practically speaking, the State's jurisdiction under the Oregon Scenic Waterways Act (ORS 390.805 to 390.925) does not extend to Federal land, even within 1/4 mile of the river.

Whether you would want to undertake the expense of exploration in these circumstances, not knowing whether mining would be permitted eventually, would be a matter of personal judgment.

Bob Potter, the State Scenic Waterways Coordinator, advises me that Federal funds have not been used for the Scenic Waterway program, either for study, administration or any other purpose.

My suggestion, Bob, is to continue to present your case for protection of the mining industry to the USFS, to our Congressional Delegation and to the next Governor, who will, I expect, have the loudest single voice in establishing the State's position on any administration proposal for the Illinois.
