The **Waldo Placer Mining Company** is reported to be constructing a small plant for the treatment of its concentrates in the Waldo district near Takilma, Oregon. Fred Galena of Takilma is manager of the company which operates the Plataurica mine.

The Mining Journal March 15 1938

Old workings of the Waldo mine are being cleaned out and retimbered by the **Waldo Copper Company**, M. M. Hughes of Takilma, Oregon, foreman. General rehabilitation work is under way in the camp and mill and the road is being put into condition for use. The property is in Josephine County near Takilma, Oregon.

Production was recently started by the **Waldo Copper Company**, M. E. Hughes of Takilma, Oregon, president and general manager, and capacity output of 50 tons daily is being maintained. Ore carries values in copper and gold and is treated in the company's 50-ton flotation mill. A new 1,350-foot tunnel is being driven and is expected to cut three known ore bodies. This ground is owned in fee by the company and is developed chiefly by a tunnel to a depth of 350 feet. H. Petrolo Collins is consulting engineer and mill superintendent and James and Max M. Hughes are foremen, all of Takilma. A crew of 14 is employed. Besides the Waldo mine the company is operating the Sunbeam gold property and taking out about 20 tons of ore daily.

The **Waldo Copper Company** has been organized to operate the Waldo mine in Josephine County near Takilma, Oregon. Max E. Kreuger and associates of Portland are said to be backing the company which was incorporated by E. E. Hughes and F. B. Mitchell of Takilma. An initial ore shipment was made from the Waldo mine by present operators last spring.
