

Proposed Grassy Mountain Gold Mine


- Applicant: Calico Resources USA Corp / Paramount Gold Nevada
 - Malheur County, ~22 miles south-southwest of Vale
 - 2.07 million short tons of mill-grade ore (gold, silver)





Proposed Grassy Mountain Gold Mine


- Permit area:
 - Private and public land
 - Mine and process area
 - Access road area (improvement)
 - Underground mine
 - Indoor ore processing facility
- 2 years of construction
- 8 years of operation
- 4 years reclamation/closure
- 27 years of post-closure monitoring





Proposed Grassy Mountain Gold Mine

- Temporary conventional mill
- Temporary waste rock storage facility (lined)
- Permanent tailings storage facility (lined)
- Ore processing plant
- Cyanide destruction process
- Placement in tailings storage facility
- Water recovered for reuse in mill
 - Groundwater supply wells





Consolidated Permitting Process – OAR Chapter 632 Division 37

- Economic growth and opportunity while protecting Oregon's environmental resources and public health and safety
- DOGAMI lead agency - coordinated process across multiple agencies
- **Technical Review Team** - interdisciplinary review of technical permitting issues and serves advisory capacity to Project Coordinating Committee
- **Project Coordinating Committee** - interagency governmental committee that shares information and coordinates permitting and provides oversight and guidance
- Transparency in review and decisions via public meetings and info sharing

Consolidated Permitting Process – Analyses and Documents

- Baseline data reports
 - Air quality, aquatic resources, environmental justice, geology, groundwater, noise, recreation, socioeconomic, wildlife...
 - Cultural resources
- Consolidated permit application
- Environmental evaluation
- Socioeconomic impact analysis
- Wildlife protection plan
- Wildlife mitigation plan
- Seep and spring monitoring plan
- Groundwater monitoring plan



State Consolidated Permitting Process – Grassy Mountain

- Jun 2012** Calico files a Notice of Intent to develop Grassy Mountain Mine
- Sep 2012** Calico files a notice of readiness to collect baseline data
- Mar 2013** Final baseline study collection plans approved by the Technical Review Team
- Jul 2015** Calico files a new Notice of Intent that changes processing facility location
- Aug 2015** Calico files a new notice to collect baseline data
- Jul 2016** Calico acquired by Paramount Gold Nevada Corp.
- Feb 2017** Calico files a new Notice of Intent that expands proposed permit boundary
- May 2017** Calico files a new notice of readiness to collect baseline data



State Consolidated Permitting Process – Project History

- Nov 2019** Calico files a Consolidated Permit Application (application)
- Feb 2020** Project Coordinating Committee holds public hearing on application completeness; DOGAMI informs Calico application is not complete
- Dec 2021** Calico files a revised application
- Feb 2023** Technical Review Team accepts final baseline data as complete
- Oct 2023** Calico files revised application; Technical Review Team accepts as complete
- Nov 2023** DOGAMI issues the Notice to Proceed with permitting process
- Aug 2024** Stantec completes the Environmental Evaluation and Socioeconomic Impact Analysis on behalf of DOGAMI




State Consolidated Permitting Process – Project History

- Oct 2024** Technical Review Team accepts the Environmental Evaluation and Socioeconomic Impact Analysis as complete; permit drafting started
- Mar 2025** Technical Review Team approves the Best Available Practicable and Necessary Technology measures
- Dec 2025** DOGAMI and state permitting agencies issue draft permits, which are posted for public review and comment

Draft Permits and Conditions - Development


Development of permits and conditions and monitoring plans by agencies focused on:

- Use of cyanide in gold extraction process
- Potential impacts on wildlife
- Water supply and impacts on groundwater and surface water
- Cultural resources impacts
- Regional employment



Draft Order

- Proposes approval of consolidated application
- Procedural history of the proposed project
- Documentation of Oregon standards compliance
- State agency responsibilities
- Required permits and approvals
- Documentation of environmental review
- Application and evaluation of Oregon standards
- Findings of fact conclusions of law
- Final order to accompany final permits





Federal National Environmental Policy Act Process

- Federal land in permit area triggered National Environmental Policy Act of 1969
- Federal process led by the Bureau of Land Management
- Parallel yet distinct from Oregon consolidated permitting process
- Environmental Impact Statement
- Record of Decision



An Introduction to DEQ

DEQ oversees a broad range of environmental regulatory programs:

Water Pollution Control Facility – Onsite

Key Components of WPCF-OS permit:

- For sanitary wastewater if no municipal connection exists.
- Proper sizing and siting to avoid groundwater contamination.





Figure 4. Schematic Diagram

Industrial Stormwater Discharge Permit

Key Components of 1200-Z permit:


- Regulates stormwater discharges associated with industrial activity from Metal Mining facilities.
 - Requires implementation of control measures to prevent pollutant discharges during construction and operation – Stormwater Pollution Control Plan (SWPCP).



Air Contaminant Discharge Permit

Key Components of ACDP permit:

- Covers emissions from milling, crushing, and processing.
- Regulations do require this facility to obtain a Title V Operating Permit (when applicable).
- This site does not require Site Specific Cleaner Air Oregon permit conditions for air toxics.



Water Pollution Control Facilities Permit

Key Components of WPCF-N permit:

- Groundwater protection
- Permit Limits
 - Wildlife exposure & human health
- Solid Waste Disposal Regulation
- Beneficial Use Determination
- Financial Assurance



Solid Waste Components of the WPCF-N

What is Solid Waste in the State of Oregon?

Any useless or discarded material is solid waste.

Solid Waste Regulations Apply to:

Mine Tailings Storage Facility

Reuse of Waste Rock within Cemented Rock Fill

Beneficial Use Determination

DEQ supports beneficial use of solid waste, such as these waste materials, in lieu of disposal at a permitted solid waste facility, as long as the proposed re-use meets conditions of the rule and is adequately protective of human health and the environment.

DEQ has evaluated the application and proposes to issue approvals of the proposed beneficial use requests.

Continued DEQ Review and Approvals

- Conduct Regular Compliance Inspections
- Review Monitoring Data and Reports
- Enforce Corrective Actions When Needed
- Maintain Long-Term Oversight Post-Closure
- Engage with Communities and Interested groups


Next Steps in Consolidated Process

 - Credible accidents bond
 - "...shall be posted before the start of any construction, excavation or other ground disturbing activity..." (OAR 632-037-0135)




