- 1. Finance charge that would have been charged in current year at the annual rate for nonsubsidized loans under like terms and conditions at the time the loan was made ..... 1.
- 2. Finance charge (including interest on the loan, the loan fee, and interest on the loan fee) as charged..... 2.
- 3. Line 1 minus line 2 ..... 3.
- 4. Limit on current year credit (4 percent of average unpaid balance of loan during the year)..... 4.
- 5. Current year credit available (lesser of line 3 or line 4) (Claim on Schedule OR-ASC-CORP using credit code 848.)..... 5.
