1. Introductions

Introductions of members, guest and staff were presented.

2. Approve February 24, 2021 Meeting Minutes

Mark Rauch moved to approve the minutes from the 2/24/2021 with minor changes, Applicant Review Committee meeting. Andre Lindauer seconded the motion. The motion passed unanimously.

3. Bolen, Bradley (61372) Application Review:

Presented by Jordan James Largent

Reason for Discretionary Review

DPSST received an Application for Training (F5) and a Criminal History Reporting form (F28) for Bradley Bolen, where he disclosed a 4/3/15 criminal disposition for *Property-Malicious Injury to Property* and *Driving-Operating Vehicle Without Owner's Consent* in Payette, Idaho. On 11/8/14, Bolen, with others, took golf carts from a local golf course and caused significant damage to the golf carts and the golf course's grounds. Bolen admitted to *Property-Malicious Injury to Property* and *Driving-Operating Vehicle Without Owner's Consent* and both were dismissed as a result of completing a juvenile Informal Adjustment. Bolen also disclosed a 2020 disposition of *Vehicle-Windshield Tint Violation* that was a non-criminal infraction that does not require review.

Staff determined that Bolen's actions related to the golf cart and his subsequent untruthfulness to the officer violates the Board's pre-employment moral fitness standards.

The committee discussed the moral fitness violation and identified the following aggravating and mitigating factors specific to this case:

Aggravating

- o Bolen attempted to minimize his behavior on F28 by only reporting "Joy Riding".
- Bolen intentionally damaged the golf cart by kicking the window and attempting to remove the governor.
- The officer noted in their report, that Bolen "smirked" during the interview.
- o Of the three involved in the incident that were interviewed, Bolen was not forthcoming and was caught in multiple lies.

Mitigating

- o Bolen has obtained a degree in Criminal Justice.
- o The time that has passed since the incident and his age at the time.
- o Bolen paid the ordered restitution.
- o Bolen was not employed at the time of the criminal disposition.
- o Bolen has been hired by the Department of Corrections, who is aware of the criminal disposition.
