1. Introductions

Introductions of members, guest and staff were presented.

2. Approve May 26, 2021 Meeting Minutes

Mark Rauch moved to approve the minutes from the 5/26/2021, Applicant Review Committee meeting. Andre Lindauer seconded the motion. The motion passed unanimously.

3. Wallace, Shawnee (61966) Application Review:

Presented by Jordan James Largent

Reason for Discretionary Review

DPSST received an Application for Training (F5) and a Criminal History Reporting form (F28) for Shawnee Wallace, where she disclosed a 1/8/12 arrest for *Assault in the Fourth Degree* after she assaulted a female in a private residence. Wallace ultimately pled guilty and was convicted of *Harassment* on 1/30/12. Wallace also reported a 2012 conviction for *Person Under 21 Purchase or Possess Alcoholic Beverage*, this is a non-criminal violation that does not required further review by DPSST.

Staff determined Wallace's conduct violates the Board's pre-employment moral fitness standards.

The committee discussed the moral fitness violation and identified the following aggravating and mitigating factors specific to this case:

• Aggravating:

- o Wallace caused harm and left physical marks on the victim.
- Wallace's mitigation letter appeared to minimize her behavior during the incident and failed to take responsibility for her actions during the incident.
- The victim's statement to police that Wallace screamed at her to "fight back".

• Mitigating:

- The incident occurred nine years ago and prior to her employment in law enforcement.
- O Wallace's age at the time of the incident.
- Wallace took responsibility by pleading guilty.
- Wallace has been hired by a law enforcement agency that is aware of the criminal disposition.
- o Wallace is active in the Oregon National Guard.
- o This is Wallace's only criminal disposition.
- Wallace's mitigation indicated that she and the victim have since resolved their issues.
