### 1. Introductions

### 2. Approve May 25, 2022 Meeting Minutes

Cody Smith moved to approve the minutes from the May 25, 2022, Applicant Review Committee meeting. Carol Dishion seconded the motion. The motion passed unanimously.

# 3. Delgadillo, Alexander (62905) Application Review: Corrections

Presented by Melissa Lang-Bacho, Professional Standards Case Manager

DPSST received an Application for Training (F5) and a Criminal History Reporting Form (F28) for Alexander Delgadillo, where he disclosed a September 4, 2019, criminal conviction for Driving-Reckless in Gem County, Idaho. Delgadillo ultimately pled guilty and was convicted of Driving-Reckless.

Delgadillo also disclosed a 2018 traffic infraction for Driving-Stop Sign-Fail to Stop in Canyon County, Idaho. This charge is an infraction and is not punishable as a crime therefore, it did not result in a criminal disposition that requires review by DPSST.

Alexander Delgadillo provided verbal mitigation for committee consideration.

The Applicant Review Committee found the following moral fitness violations and factors:

### Moral Fitness Violations:

- Dishonesty: Delgadillo was deceptive when he indicated to police that the license plate on the motorcycle he was riding belonged to his previous motorcycle.
- Gross Misconduct: Delgadillo was reckless when he failed to pull over for police and drove his motorcycle at high speeds, which could have caused significant harm to persons and property.

# Aggravating Factors:

- Switching license plates, as described in the police reports, could have been a felony charge, if it occurred in Oregon.
- It has only been three years since Delgadillo pled guilty to the misdemeanor, *Driving-Reckless* charge.
- Delgadillo was reckless and endangered people.

# Mitigating Factors:

- Delgadillo's presence at the ARC meeting demonstrated that he understands how the actions of his past can impact his future career.
- Delgadillo had a natural fight-or-flight reaction when he saw the police officer and ran.
- Delgadillo ultimately took responsibility and turned himself into law enforcement.
- Delgadillo had just become old enough to be considered an adult at the time of the incident.
- Delgadillo was unaware that it was illegal to switch license plates between his motorcycles but did disclose to the officer what happened.
- The Department of Corrections hired Delgadillo with knowledge of his criminal history.
- Delgadillo's criminal citation occurred prior to his employment in a certifiable position.

# 4. <u>Forrest, Andrea (62966) Application Review: Telecommunications/Emergency Medical</u> Dispatch

DPSST received an Application for Training (F5) and a Criminal History Reporting Form (F28) for Andrea Forrest (Boothby), where she disclosed a criminal citation for *Theft in the Third Degree*. Forrest ultimately pled no contest on April 25, 2019, and was granted a diverted sentence which was completed and *Theft in the Third Degree* was dismissed.

The Applicant Review Committee found the following moral fitness violations and factors:

#### Moral Fitness Violations:

- Dishonesty: Forrest received a criminal citation for *Theft in the Third Degree*, which is a crime that involves dishonesty.
- Gross Misconduct: The committee did not identify elements of gross misconduct.

### Aggravating Factors:

- Forrest was on video picking up nasal spray in one aisle, then opening and discarding the packaging in another aisle, placing the nasal spray in her pocket and leaving the store.
- Two weeks after the event occurred, she checked her coat pocket and found the nasal spray; due to the area of the state and time of year would make it unrealistic that she did not use her coat prior to that.

# Mitigating Factors:

- Forrest turned herself in to the police after she saw her photo posted online.
- Forrest provided a bank statement reflecting that she had paid for other items while shopping at the store that day.
- Forrest indicated she does not remember taking the nasal spray because of a medical condition which is a plausible reason to question her state of mind at the time of the incident.
- The Harney County Sheriff's Office hired Forrest with knowledge of her criminal history.
- Forrest's criminal citation occurred prior to her employment in a certifiable position.
