1. Minutes from March 31, 2020

2. *Approval of Temporary and Proposed Rule Changes to Establish Procurement Processes for Goods and Services through Federal Programs

Presented by Jennifer Howald

The Public Contracting Code allows a purchase through a federal program to be completed without use of the competitive sealed bidding, sealed proposals or other competition required under the Code if the procurement is made in accordance with rules adopted by the contracting agency and federal laws.

The Department follows the Attorney General’s Model Rules for public contracting. The Model Rules do not include a rule for procurement through federal programs.

In order for the Department to be able to purchase goods and services through a federal program utilizing the Public Contracting Code’s statutory exemption to competitive processes, the

*Requires a vote by the Committee.

Department needs to adopt a rule establishing procedures for such contracts in order to be in compliance with the Public Contracting Code.

John Teague made a motion to approve the Adoption of the rule as described. James Oeder seconded the motion. By a roll call of members present, the motion carried with a unanimous vote.

3. *Edward Sharpe – Representing Health Care Industry, Re-Appointment to the Private Security/Investigator Policy Committee, 2nd term effective 8/14/2020.
